Chief Mee introduced the future owners, Gary Mueller and Gary Kosmatka. Their sale closing may take place as early as Thursday, September, 8, 2011. The incorporation is already established. The owners would like no disruption of business during the transition. Chief Mee reported that half of the fingerprinting inspection has been completed. Results of the other fingerprint inspection should be returned this week. Mueller had worked for Thom McNamee for many years at his different bars. The General Manager will be Beth Kosmatka who had worked for Bandito Barney's for 12 years. For now, the name will stay Rosie O'Hare's. Chief Mee recommends approval of the license, conditioned upon the closing of the sale, receipt of the results of the other fingerprint inspection, and receipt of the surety bond. He will hold the license until the sale takes place and the other conditions are satisfied. The name listed on the license will be "Irish Rebels, LLC dba Rosie O'Hare's Public House".

Roll: Ayes – 2 – Trustee Miller and President Bartels. Nays – 0. Absent – 1 – Trustee Ruffulo. Motion carries.

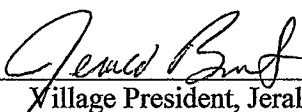

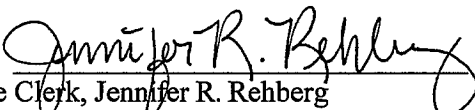
