Blackerby stated the rate would be adjusted to collect the total dollar amount the same as last year. Gorman stated this was discussed at a Committee of the Whole and tax swaps, introduced by Skillicorn. Bartels stated this is symbolism. O'Connor read the amendment to the motion with correct language. Bartels asked that the record show that he would rather cut rates if we are going to give something back to the residents.
