Because of the amount of space and type of operation, the Citgo station does not qualify for an E-1 license. Mr. Glogovsky states that he operates a station in Lake County and he is allowed to sell “mini’s” under their license. He assures the Commission that the “mini’s” would be kept in a cabinet behind the counter. Trustee VanOstenbridge would like to know Lake Bluff’s definition of their license. Chief Pena agrees and will do the research and come back in front of the Commission with his findings. The Chief suggests the Commission take action to confirm recommendation to the full Board to increase the license by one and award the license to Glogovsky Oil Co. DBA: East Dundee Citgo.
