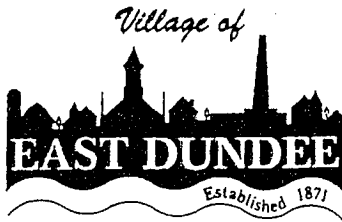



YOU ARE HEREBY NOTIFIED, pursuant to Section 149 of the Illinois Liquor Control Act and as the holder of a Class G liquor license of the Village of East Dundee, Illinois, that the Liquor Control Commission of the Village of East Dundee shall hold a public hearing for which your appearance is required at 6:00 p.m. on the 17th day of January, 2012, in the Village Hall at 120 Barrington Avenue, East Dundee, Illinois, to determine what action, if any, should be taken on your license by reason of the following, to wit:

That on Sunday, December 11, 2011, on the licensed premises at 940 Dundee Ave., East Dundee, IL 60118, patrons of the facility were permitted to remain within the premises from the time of 2:00 a.m. until about 2:07 a.m. on that date, at a time when by Village Ordinance you were not allowed to serve or allow the consumption of alcoholic beverages on the premises (due to the hour and the end alcohol service time of 2:00 a.m. on that weekend day); at which time it was observed that in excess of approximately 30 patrons were consuming alcoholic beverages in violation of East Dundee Village Ordinance Section 116.08(M).

That on Sunday, December 11, 2011, from the time of 2:00 a.m. until about 2:07 a.m., on the licensed premises at 940 Dundee Ave., East Dundee, IL 60118, in excess of approximately 30 patrons were unlawfully, due to the hour and at a time of prohibited alcoholic beverage service, consuming alcoholic beverages in violation of East Dundee Village Ordinance Section 116.09(D).
