**AN ORDINANCE OF THE VILLAGE OF EAST DUNDEE, COOK AND KANE COUNTIES, ILLINOIS, AMENDING THE TRAFFIC CODE FOR THE VILLAGE BY REGULATING TRUCK USAGE NEAR RESIDENTIAL PROPERTIES AND TRUCK ROUTES**

**WHEREAS**, the Village of East Dundee, Cook and Kane Counties, Illinois (the “Village”) is a duly organized and validly existing home-rule municipality created in accordance with the Constitution of the State of Illinois of 1970 and the laws of the State; and,

**WHEREAS**, the Village desires to regulate truck usage near residential areas during certain hours and to regulate daytime and nighttime truck routes in the Village to protect the public health and welfare, and the environment by reducing noise, emissions and conserving fuel.

**NOW, THEREFORE, BE IT ORDAINED** by the President and Board of Trustees of the Village of East Dundee, Cook and Kane Counties, Illinois, as follows:

**Section 1:** The above recitals are incorporated herein and made a part of this Ordinance.

**Section 2:** That Title VII, Chapter 70 of the Code of the Village of East Dundee is hereby amended by adding Section 70.11 to read as follows:

**“§ 70.11 MOTOR TRUCK RESTRICTIONS**

(A) *Definitions.* For the purposes of this section the following definitions shall apply unless the context clearly indicates or requires a different meaning.

**MOTOR TRUCK.** Every motor vehicle designed, used or maintained primarily for the transportation of property, which holds a license plate classification of F through Z pursuant to Section 3-815(a) of the Illinois Vehicle Code, 625 ILCS 5/3-815(a).

**TRUCK TRACTOR.** Every motor vehicle designed and used primarily for drawing other vehicles and not so constructed as to carry a load other than a part of the weight of the vehicle and load so drawn, which holds a license plate classification of F through Z pursuant to Section 3-815(a) of the Illinois Vehicle Code, 625 ILCS 5/3-815(a).

(B) *Motor truck and truck tractor usage prohibited.* It shall be unlawful for a person that operates a motor truck or truck tractor in the Village to start said motor truck or truck tractor, when it is parked within 125 feet of a residential property, between the hours of 1:00 a.m. and 5:30 a.m.

(C) *Truck route restrictions.*

(1) The required truck route for motor trucks and truck tractors traveling to and from the facility located at 306 East Third Street, East Dundee, Illinois, shall be: Third Street to Barrington Avenue to Route 68 to Route 72/Main Street.

(D) *Signage.* The Public Works Director is hereby authorized and directed to erect and maintain specialized traffic signs in order to give notice of this regulation.”

**Section 3:** That this Ordinance shall be in full force and effect from and after its passage, approval, and publication in pamphlet form as provided by law.
