

RESOLUTION NUMBER 29 - 03

**RESOLUTION AUTHORIZING AN AMENDMENT  
TO THE EAST DUNDEE FACILITY PLANNING AREA**

**WHEREAS**, the Village of East Dundee has previously annexed certain property in Cook County within its municipal boundaries located in Cook County commonly known as Spring Lake Quarry, generally north of Illinois State Route 72 and west of Healy Road; and

**WHEREAS**, the Village of East provides municipal sanitary sewer service within the East Dundee Facility Planning Area; and

**WHEREAS**, such property located in Cook County commonly known as Spring Lake Quarry, generally north of Illinois State Route 72 and west of Healy Road is within the Barrington Facility Planning Area; and

**WHEREAS**, the Village of East Dundee desires to bring such area within the East Dundee Facility Planning Area and provide municipal sanitary sewer service to such property.

**NOW THEREFORE BE IT RESOLVED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF EAST DUNDEE, COOK AND KANE COUNTIES, ILLINOIS, AS FOLLOWS:**

**Section One.** That the Village of East Dundee take such action as is necessary to effect an amendment to its Facility Planning Area to include the

property commonly known as Spring Lake Quarry and that appropriate applications be made to the Northeastern Illinois Planning Commission to undertake a Water Quality Management Plan Amendment to transfer such property from the Barrington Facility Planning Area to the East Dundee Facility Planning Area.

**Section Two. Severability.** If any section, paragraph or provision of this resolution shall be held to be invalid or unenforceable for any reason, the invalidity or unenforceability of such section, paragraph or provision shall not affect any of the remaining provisions of this resolution.

**Section Three. Repeal.** All ordinances, resolutions, motions or parts thereof in conflict herewith shall be and the same are hereby repealed.

**Section Four. Publication.** This resolution shall be in full force and effect forthwith upon its adoption, approval and publication in pamphlet form as provided by law.
