

ORDINANCE NUMBER 08 - 14

**ORDINANCE AMENDING ANNUAL FEE SCHEDULE
FOR THE VILLAGE OF EAST DUNDEE**

WHEREAS, the Village of East Dundee is a home rule unit of local government under and pursuant to Section 6 of Article VII of the Constitution of the State of Illinois, has the authority to exercise any power and perform any function pertaining to its government and affairs, including but not limited to the power to regulate for the protection of the public health, safety, morals, and welfare; and

WHEREAS, the President and Board of Trustees of the Village of East Dundee having determined that it is in the best interests of the health, safety and welfare of the residents of the Village of East Dundee that the Annual Fee Schedule be amended.

NOW THEREFORE BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF EAST DUNDEE, COOK AND KANE COUNTIES, ILLINOIS, AS FOLLOWS:

Section One. That the Annual Fee Schedule of the Village of East Dundee is hereby amended as follows:

CHAPTER 50 - REGULATIONS

1. Garbage and Refuse (Sec. 50.02): \$50.00
(Full fine amount is due and may be payable by mail within 30 days of issue. 50% of fine amount may be paid by mail if done so within 15 days of issue date.)

CHAPTER 51 - WATER SERVICE

3. Illegal Watering (Sec. 51.21(B)): \$50.00
(Full fine amount is due and may be payable by mail within 30 days of issue. 50% of fine amount may be paid by mail if done so within 15 days of issue date.)

CHAPTER 72 - TRAFFIC CODE

3. Traffic Violations:

A. Clinging to Moving Vehicles (Sec. 70-11-1490): \$100.00

(Full fine amount is due and may be payable by mail within 30 days of issue. 50% of fine amount may be paid by mail if done so within 15 days of issue date.)

B. Use of Coasters, Roller Skates and Similar Devices (Sec. 70-11-1491) \$50.00

(Full fine amount is due and may be payable by mail within 30 days of issue. 50% of fine amount may be paid by mail if done so within 15 days of issue date.)

CHAPTER 92 - ANIMALS

6. Dangerous Animals (Non-Domestic) (Sec. 92.03): \$30.00

7. Vicious Animals (Sec. 92.04): \$30.00

8. Dog/Cat Unleashed (Sec. 92.08(C)(1)): \$30.00

CHAPTER 93 - NUISANCES

3. Noxious Plants/High Weeds (Sec. 93.07(A)): \$50.00

(Full fine amount is due and may be payable by mail within 30 days of issue. 50% of fine amount may be paid by mail if done so within 15 days of issue date.)
