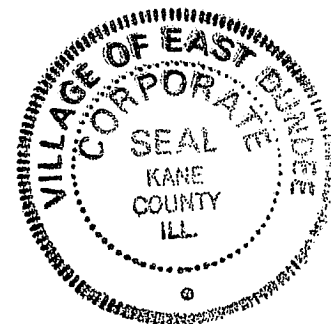



ORDINANCE NUMBER 11 - 52

ORDINANCE LEVYING TAXES FOR CORPORATE PURPOSES
AND SPECIAL FUNDS FOR THE FISCAL YEAR COMMENCING
MAY 1, 2011 AND ENDING APRIL 30, 2012 FOR THE VILLAGE OF
EAST DUNDEE, KANE AND COOK COUNTIES, ILLINOIS

BE IT ORDAINED by the President and Board of Trustees of the Village of East Dundee,
Counties of Kane and Cook, State of Illinois, THAT:

Section One. Levy Amount. That the total amount of appropriations for all corporate purposes legally made to be collected from the tax levy of the current fiscal year is ascertained to be the sum of Six Hundred Ten Thousand and Sixty and 00/100 Dollars (\$610,060.00).

Section Two. Levying Clause. That the sum of Six Hundred Ten Thousand and Sixty and 00/100 Dollars (\$610,060.00) being the total of appropriations heretofore legally made which are to be collected from the tax levy of the current fiscal year of the Village of East Dundee for all corporate purposes of said Village, as appropriated for the current fiscal year by an ordinance adopting the 2011-2012 Annual Budget of the Village of East Dundee for the May 1, 2011 through April 30, 2012 fiscal year passed by the President and the Board of Trustees of said Village at the legally convened meeting of April 25, 2011, as Ordinance No. 11-26, be and the same is hereby levied upon all taxable property of the Village of East Dundee subject to taxation for the current year, the specific amounts as levied for the certain tax levy purposes being included herein by being placed under separate column under the heading "To Be Raised By Tax Levy" which appears over the same, the tax so levied being for the current fiscal year of said Village and for the said appropriation to be collected from said tax levy, the total of which has been ascertained as aforesaid and being as follows:

Section Three. That the total amount of Six Hundred Ten Thousand and Sixty and 00/100 Dollars (\$610,060.00) ascertained above, be and is hereby levied and assessed on all property subject to taxation within the Village of East Dundee according to the value of said property as assessed and equalized for the State and County purposes for the current year.

Section Four. That there is hereby certified to the County Clerks of Kane and Cook Counties, Illinois, the several sums above, constituted said total amount, and the total amount Six Hundred Ten Thousand and Sixty and 00/100 Dollars (\$610,060.00), which total amount the Village of East Dundee requires to be raised by taxation for the current fiscal year of the Village, and the Village Clerk is hereby ordered and directed to file with the county Clerks of the Counties of Kane and Cook on or before the time required by law, a certified copy of this ordinance.

Section Five. Severability. If any section, paragraph or provision of this ordinance shall be held to be invalid or unenforceable for any reason, the invalidity or unenforceability of such section, paragraph or provision shall not affect any of the remaining provisions of this ordinance.

Section Six. Repeal. All ordinances, resolutions, motions or parts thereof in conflict herewith shall be and the same are hereby repealed.

Section Seven. Publication. This ordinance shall be in full force and effect forthwith upon its adoption, approval and publication in pamphlet form as provided by law.
