

Ordinance No. 116-18

AN ORDINANCE OF THE VILLAGE OF EAST DUNDEE, ILLINOIS, COOK AND KANE COUNTIES, ILLINOIS, AMENDING THE REGULATIONS RELATING TO SIDEWALK SERVICE ENDORSEMENTS AND VILLAGE RIGHT-OF-WAY SERVICE ENDORSEMENTS

WHEREAS, the Village of East Dundee (the “*Village*”) is a duly organized and validly existing home-rule municipality created in accordance with the Constitution of the State of Illinois of 1970 and the laws of the State; and,

WHEREAS, the Village pursuant to its home rule powers has the authority to exercise any power and perform any function pertaining to its government and affairs including the power to regulate for the protection of the public health, safety and welfare; and,

WHEREAS, Article IV of the Liquor Control Act (235 ILCS 5/4-1) authorizes the Village to determine the number, kind and classification of licenses for the retail sale of alcoholic liquor and establish rules and regulations regulating the sale of alcoholic beverages; and,

WHEREAS, pursuant to its home rule authority, the Village desires to amend Chapter 116 of the Code of the Village of East Dundee by setting forth regulations pertaining Sidewalk Service Endorsements and Village Right-Of -Way Service Endorsement (Village sponsored events) in order to clarify the application process and the dates when said endorsements shall be valid.

NOW, THEREFORE, BE IT ORDAINED by the President and Board of Trustees of the Village of East Dundee, Cook and Kane County, Illinois, as follows:

Section 1. That the preambles of this Ordinance are hereby incorporated into this Section as if set out herein in full.

Section 2: That Section 116.05(A)(18)(q) of the Code of Ordinances of the Village of East Dundee, as amended, is hereby deleted in its entirety and replaced with the following:

“ (q) Every applicant for an endorsement for a sidewalk service area shall annually file an application with the Village Clerk upon a form provided by the Village Clerk and pay a filing fee of \$100, which shall not be refundable. Said application shall be submitted to the Village by the applicant no later than March 1st of each year.”

Section 3: That Section 116.05(A)(18)(r) of the Code of Ordinances of the Village of East Dundee, as amended, is hereby deleted in its entirety and replaced with the following:

“ (r) An endorsement for operation of a sidewalk service area which is granted shall permit operation between May 1st and November 1st of that calendar year only.”

Section 4: That Section 116.05(A)(20)(h) of the Code of Ordinances of the Village of East Dundee, as amended, is hereby deleted in its entirety and replaced with the following:

“(h) Every applicant for an endorsement for a right-of-way service area shall annually file an application with the Village Clerk upon a form provided by the Village Clerk and pay a filing fee of \$100, which shall not be refundable. Said application shall be submitted to the Village by the applicant no later than March 1st of each year.”

Section 5: That the Section 116.05(A)(20) of the Code of Ordinances of the Village of East Dundee, as amended, is hereby amended by adding the following subsection:

“(j) An endorsement for operation of a right-of-way service area which is granted shall permit operation between May 1st and November 30th of that calendar year only.”

Section 6: This Ordinance shall be in full force and effect upon its passage, approval, and publication in pamphlet form as provided by law.


