

ORDINANCE NUMBER 08 - 49

**ORDINANCE GRANTING A SPECIAL USE FOR
THE PROPERTY COMMONLY KNOWN AS
UNDEVELOPED PROPERTY AT SOUTHEAST CORNER OF
ROUTE 25 AND ROUTE 68, EAST DUNDEE, ILLINOIS**

WHEREAS, the Village of East Dundee is a home rule unit of local government under and pursuant to Section 6 of Article VII of the Constitution of the State of Illinois, has the authority to exercise any power and perform any function pertaining to its government and affairs, including but not limited to the power to regulate for the protection of the public health, safety, morals, and welfare; and

WHEREAS, application has been made by Corporate Design and Development Group LLC under Petition No. P/Z 08-07-01 requesting a special use pursuant to 157.052(D)(7) to allow the establishment and operation of a gas station on property commonly known as undeveloped property at southeast corner of route 25 and Route 68, Village of East Dundee, Illinois; and

WHEREAS, the Planning and Zoning Commission (hereinafter the "Commission") of the Village of East Dundee, pursuant to notice and pursuant to the Village of East Dundee Code of Ordinances, Chapter 156.05(B)(3) held a hearing on June 12, 2008, on Petition No. P/Z 08-07-01; and

WHEREAS, pursuant to said hearing, the Commission approved the Petition by a vote of 7 ayes, 0 naves and 2 absent.

NOW THEREFORE BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF EAST DUNDEE, KANE AND COOK COUNTIES, ILLINOIS, AS FOLLOWS:

Section One. That the recommendation of the Commission is hereby approved and adopted.

Section Two. That a special use for the property commonly known as undeveloped property at southeast corner of Route 25 and Route 68, Village of East Dundee, Illinois, requested pursuant to Petition No. P/Z 08-07-01 is hereby granted to allow the establishment and operation of a gas station,

subject to preliminary and final plat approval and compliance with the Village Engineer's memorandum dated July 9, 2008, for property commonly known as undeveloped property at southeast corner of Route 25 and Route 68, East Dundee, Illinois.

Section Three. Severability. If any section, paragraph or provision of this ordinance shall be held to be invalid or unenforceable for any reason, the invalidity or unenforceability of such section, paragraph or provision shall not affect any of the remaining provisions of this ordinance.

Section Four. Repeal. All ordinances, resolutions, motions or parts thereof in conflict herewith shall be and the same are hereby repealed.

Section Five. Publication. This ordinance shall be in full force and effect forthwith upon its adoption, approval and publication in pamphlet form as provided by law.
