RESOLUTION TO EXPEDITE THE ISSUANCE OF PERMITS TO THE VILLAGE OF EAST DUNDEE BY IDOT

WHEREAS, The Village of East Dundee, located in Cook and Kane County, State of Illinois, desires to undertake n the years 2012 and 2013, the location, construction, operation and maintenance of driveways and street returns, water mains, sanitary and storm sewers, street light, traffic signals, sidewalk, landscaping, etc., on State highways, within the Village of East Dundee, which by law and/or agreement come under the jurisdiction and control of the department of Transportation of the State if Illinois hereinafter referred to as Department, and,

WHEREAS, an individual working permit must be obtained from the Department prior to any of the aforesaid installations being constructed either by the Village of East Dundee or by a private person of firm under contract and supervision of the Village of East Dundee.

NOW THEREFORE BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF EAST DUNDEE, COOK AND KANE COUNTIES, ILLINOIS, AS FOLLOWS:

Section One. The Village of East Dundee hereby pledges its good faith and guarantees that all work shall be performed in accordance with conditions of the permit to be granted by the Department, and to hold State of Illinois harmless during the prosecution of such work, and assume all liability for damages to person or property due to accidents or otherwise by reason of the work which is to be performed under the provision of said permit.

<u>Section Two</u>. That all authorized officials of the Village of East Dundee are hereby instructed and authorized to sign said working permit on behalf of the Village of East Dundee.

<u>Section Three</u>. Severability. If any section, paragraph or provision of this ordinance shall be held to be invalid or unenforceable for any reason, the validity or unenforceability of such section, paragraph or provision shall not affect any of the remaining provisions of this ordinance.

<u>Section Three</u>. Repeal. All ordinances, resolutions, motions or parts thereof in conflict herewith shall be and the same are hereby repealed.

Section Four. Publication. This ordinance shall be in full force and effect forthwith
upon its adoption, approval and publication in pamphlet form as provided by law.
