

ORDINANCE NO. 04-42

AN ORDINANCE LEVYING TAXES FOR CORPORATE PURPOSES AND SPECIAL FUNDS FOR THE CURRENT FISCAL YEAR COMMENCING MAY 1, 2004, AND ENDING APRIL 30, 2005, FOR THE VILLAGE OF EAST DUNDEE, ILLINOIS.

BE IT ORDAINED by the President and Board of Trustees of the Village of East Dundee, Counties of Kane and Cook, State of Illinois, THAT:

Section 1. Levy Amount. That the total amount of appropriations for all corporate purposes legally made to be collected from the tax levy of the current fiscal year is ascertained to be the sum of Four Hundred Forty Thousand One Hundred Fifty Dollars (\$440,150.00).

Section 2. Levying Clause. That the sum of Four Hundred Forty Thousand One Hundred Fifty Dollars (\$440,150.00) being the total of appropriations heretofore legally made which are to be collected from the tax levy of the current fiscal year of the Village of East Dundee for all corporate purposes of said Village, as appropriated for the current fiscal year by an ordinance adopting the 2004 – 2005 Annual Budget of the Village of East Dundee for the year 2004 – 2005 passed by the President and the Board of Trustees of said Village at the legally convened meeting of April 19, 2004, as Ordinance No. 04-08, be and the same is hereby levied upon all taxable property of the Village of East Dundee subject to taxation for the current year, the specific amounts as levied for the certain tax levy purposes being included herein by being placed under separate column under the heading “To Be Raised By Tax Levy” which appears over the same, the tax so levied being for the current fiscal year of said Village and for the said appropriation to be collected from said tax levy, the total of which has been ascertained as aforesaid and being as follows:

Section 3. That the total amount of Four Hundred Forty Thousand One Hundred Fifty Dollars (\$440,150.00) ascertained above, be and is hereby levied and assessed on all property subject to taxation within the Village of East Dundee according to the value of said property as assessed and equalized for the State and County purposes for the current year.

Section 4. That there is hereby certified to the County Clerks of Kane and Cook Counties, Illinois, the several sums above, constituted said total amount, and the total amount of Four Hundred Forty Thousand One Hundred Fifty Dollars (\$440,150.00), which total amount the Village of East Dundee requires to be raised by taxation for the current fiscal year of the Village, and the Village Clerk is hereby ordered and directed to file with the county Clerks of the Counties of Kane and Cook on or before the time required by law, a certified copy of this ordinance.

Section 5. That to the extent the levy set forth in this Ordinance exceeds any limitation imposed by Public Act 87-17, the Property Tax Extension Limitation Act, the Clerks of Kane and Cook Counties are hereby directed to make any reduction in the levy extension from the Corporate Fund levy, rather than proportionately from the levy for each fund set forth herein.

Section 6. Severability. If any section, paragraph or provision of this ordinance shall be held to be invalid or unenforceable for any reason, the invalidity or unenforceability of such section, paragraph or provision shall not affect any of the remaining provisions of this ordinance.

Section 7. Publication. That this ordinance shall take effect and be in full force and effect immediately on and after its passage and approval.

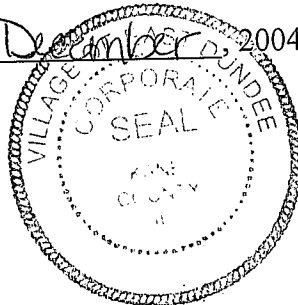
