

RESOLUTION NO. 09 - 03

**RESOLUTION AUTHORIZING THE
EXECUTION OF A PLAT OF RE-SUBDIVISION
FOR LOTS 6 AND 7 IN THE
PRAIRIE LAKE INDUSTRIAL PARK**

WHEREAS, the corporate authorities of the Village of East Dundee have determined that it is advisable, necessary and in the public interest that the Village authorize the execution of a Plat of Re-Subdivision for the property commonly known as Lots 6 and 7 of the Prairie Lake Industrial Park Subdivision, a true copy of the Plat of Re-Subdivision is attached hereto as an exhibit.

NOW, THEREFORE, BE IT RESOLVED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF EAST DUNDEE, COOK AND KANE COUNTIES, ILLINOIS, AS FOLLOWS:

Section One. That the Village of East Dundee adopts and approves and the President be and he is hereby authorized and directed to sign and the Village Clerk is directed to attest to the execution of the Plat of Re-Subdivision for Lots 6 and 7 legally described as follows: Re-subdivision of Lots 6 and 7 in Prairie Lake Industrial Park Subdivision, being a part of Lots 6 and 7 in Prairie Lake Industrial Park Third Re-Subdivision being a re-subdivision of part of the Southeast Quarter of Section 13 and part of the Northeast Quarter of Section 24, all in Township 42 North, Range 8 East of the Third Principal Meridian, according to the Plat thereof recorded February 27, 2001, as Document No. 2001K018788, in the Village of East Dundee, Kane County, Illinois, a true copy of which Plat of Re-Subdivision is attached hereto as an exhibit.

Section Two. Severability. If any section, paragraph or provision of this resolution shall be held to be invalid or unenforceable for any reason, the invalidity or unenforceability of such section, paragraph or provision shall not affect any of the remaining provisions of this resolution.

Section Three. Repeal. All ordinances, resolutions, motions or parts thereof in conflict herewith shall be and the same are hereby repealed.

Section Four. Publication. This resolution shall be in full force and effect forthwith upon its adoption, approval and publication in pamphlet form as provided by law.
