

Ordinance No. 13-26

AN ORDINANCE OF THE VILLAGE OF EAST DUNDEE, KANE AND COOK COUNTIES, ILLINOIS ENACTING A MORATORIUM ON TATTOOING BUSINESSES

WHEREAS, the Village of East Dundee, Kane and Cook Counties, Illinois (the "*Village*"), is a duly organized and validly existing home rule municipality of the State of Illinois pursuant to the 1970 Illinois Constitution; and,

WHEREAS, pursuant to the Village's home rule authority, the President and Board of Trustees of the Village (collectively, the "Corporate Authorities") may provide for and allow the classification of uses in its zoning ordinance; and,

WHEREAS, the Village Administrator has requested that the Village staff be given time to undertake a review and study of the appropriate regulation and classification of tattooing businesses in the East Dundee Zoning Chapter; and,

WHEREAS, the review of tattooing uses in the Village is necessary because of the need to;

- Develop new definitions to more clearly identify tattooing uses,
- Identify whether tattooing uses should be designated as permitted or special uses,
- Determine in which zoning districts tattooing uses shall be either a permitted or special use,
- Review the impact of tattooing businesses on the development in the Business Districts,
- Determine if tattooing businesses should be subject to additional regulations; and,

WHEREAS, the Corporate Authorities finds that the review of tattooing uses in the Village is in the public interest and that no consideration or development activity of new tattooing uses should be allowed until the Village has had the opportunity to review amendments to the Village's zoning and business regulations; and

WHEREAS, Corporate Authorities finds that the Village has the authority to establish a moratorium on consideration or development of new tattooing uses to keep the status quo on their development within the Village and hereby adopts this Ordinance pursuant to its home rule authority.

NOW, THEREFORE, BE IT ORDAINED by the President and Board of Trustees of the Village of East Dundee, Kane and Cook Counties, Illinois, as follows:

Section 1: That a moratorium on the review, consideration or approval of new tattooing uses in the Village in the East Dundee be and is hereby established for a period of six (6) months from the effective date of this Ordinance or until such amendments are considered by the Village Board, whichever occurs first.

Section 2: That the Village staff is hereby directed to study and investigate the issues regarding tattooing uses as heretofore stated in this Ordinance and to recommend changes to the East Dundee Zoning Chapter for consideration of text amendments pursuant to Section 157.223 of the Zoning Chapter.

Section 3: This Ordinance shall be in full force and effect from and after its passage and approval by the corporate authorities as provided by law.


