

ORDINANCE NUMBER 11 - 16

**ORDINANCE AMENDING TITLE VII, TRAFFIC CODE,
CHAPTER 70, GENERAL PROVISIONS,
SECTION 70.03, ADDITIONS, BY AMENDING §70-11-1492**

WHEREAS, the Village of East Dundee is a home rule unit of local government under and pursuant to Section 6 of Article VII of the Constitution of the State of Illinois, has the authority to exercise any power and perform any function pertaining to its government and affairs, including but not limited to the power to regulate for the protection of the public health, safety, morals, and welfare; and

WHEREAS, the President and Board of Trustees of the Village of East Dundee having determined that it is in the best interests of the health, safety and welfare of the residents of the Village of East Dundee that Title VII, Traffic Code, Chapter 70, General Provisions, Section 70.03, Additions, be amended by amending §70-11-1492.

NOW THEREFORE BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF EAST DUNDEE, COOK AND KANE COUNTIES, ILLINOIS, AS FOLLOWS:

Section One. That Title VII, Traffic Code, Chapter 70, General Provisions, Section 70.03, Additions, §70-11-1492, of the Village of East Dundee Code of Ordinances is hereby amended to read:

§70.03 ADDITIONS.

' 70-11-1492 DAMAGE TO PROPERTY.

It shall be unlawful for any person for any reason to operate any vehicle in a manner so as to willfully, maliciously, wantonly, negligently or otherwise, injure, deface, destroy or damage property, whether real property, personal property or mixed property.

Section Two. Severability. If any section, paragraph or provision of this ordinance shall be held to be invalid or unenforceable for any reason, the validity or unenforceability of such section, paragraph or provision shall not affect any of the remaining provisions of this ordinance.

Section Three. Repeal. All ordinances, resolutions, motions or parts thereof in conflict herewith shall be and the same are hereby repealed.

Section Four. Publication. This ordinance shall be in full force and effect forthwith upon its adoption, approval and publication in pamphlet form as provided by law.
