

ORDINANCE NUMBER 19 - 25

AN ORDINANCE OF THE VILLAGE OF EAST DUNDEE, COOK
AND KANE COUNTIES, ILLINOIS, MAKING DELETIONS TO CERTAIN
PROVISIONS OF THE NATIONAL ELECTRIC CODE
APPLICABLE IN THE VILLAGE OF EAST DUNDEE

WHEREAS, the Village of East Dundee ("Village") is a home rule unit of local government pursuant to Section 6 of Article VII of the Constitution of the State of Illinois, and has the authority to exercise any power and perform any function pertaining to its government and affairs; and

WHEREAS, the President and Board of Trustees of the Village have deemed it to be in the best interest of the Village that the Village of East Dundee Village Code ("Village Code") be amended by making deletions to the certain of the provisions of the National Electrical Code applicable in the Village;

NOW THEREFORE BE IT ORDAINED BY THE VILLAGE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF EAST DUNDEE, COOK AND KANE COUNTIES, ILLINOIS, AS FOLLOWS:

SECTION 1: Incorporation. That each Whereas paragraph above is incorporated by reference into this Section 1 and made a part hereof as material and operative provisions of this Ordinance.

SECTION 2: Village Code Amendment. That the Village Code is hereby amended as follows:

Amendment One:

Section 151.011(K)(4) of the Village Code, entitled "Pad Mounted Transformer," is hereby amended as follows, with additions underlined and deletions struck through:

All underground conduit shall be four-inch PVC or rigid galvanized pipe. ~~In the case of PVC, a concrete envelope will be required with voltages 480v and higher.~~ One spare conduit will be installed on all underground services.

Amendment Two:

Section 151.011(Q)(3) of the Village Code is hereby deleted in its entirety.

SECTION 3: Continuation. That all provisions of the Village Code not amended herein shall remain in full force and effect.

SECTION 4: Severability. That if any Section, paragraph or provision of this Ordinance shall be held to be invalid or unenforceable for any reason, the invalidity or unenforceability of such Section, paragraph or provision shall not affect any of the remaining provisions of this Ordinance.

SECTION 5: Repeal. That all ordinances, resolutions, motions or parts thereof in conflict with this Ordinance shall be and the same are hereby repealed.

SECTION 6: Effect. That this Ordinance shall be in full force and effect upon its adoption, approval and publication in pamphlet form as provided by law.




