**ORDINANCE GRANTING APPROVAL OF THE 2010
COMPREHENSIVE PLAN ADDENDUM**

WHEREAS, the Village of East Dundee is a home rule unit of local government under and pursuant to Section 6 of Article VII of the Constitution of the State of Illinois, has the authority to exercise any power and perform any function pertaining to its government and affairs, including but not limited to the power to regulate for the protection of the public health, safety, morals, and welfare; and

WHEREAS, the Planning and Zoning Commission (hereinafter the "Commission") of the Village of East Dundee, pursuant to notice and pursuant to the East Dundee Code of Ordinances, Chapter 156.05(B)(3) held a hearing on February 9, 2010 and continued on March 9, 2010; and

WHEREAS, pursuant to said hearing, the Commission approved the Comprehensive Plan Addendum by a vote of 4 ayes, 1 nay, and 4 absent.

NOW THEREFORE BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF EAST DUNDEE, KANE AND COOK COUNTIES, ILLINOIS, AS FOLLOWS:

Section One. That the Commission hereby approved and adopted the Village of East Dundee Comprehensive Plan Addendum dated March 9, 2010, and recommends that the Village of East Dundee adopts and approves the March 9, 2010 Comprehensive Plan Addendum, a copy of which is attached hereto and made a part hereof.

Section Two. That the Village of East Dundee Comprehensive Plan Addendum update dated March 9, 2010 is consistent with the layout, uses, density and intensity of the area.

Section Three. Severability. If any section, paragraph or provision of this ordinance shall be held to be invalid or unenforceable for any reason, the invalidity or unenforceability of such section, paragraph or provision shall not affect any of the remaining provisions of this ordinance.

Section Four. Repeal. All ordinances, resolutions, motions or parts thereof in conflict herewith shall be and the same are hereby repealed.

Section Five. Publication. This ordinance shall be in full force and effect forthwith upon its adoption, approval and publication in pamphlet form as provided by law.
