

Ordinance No. 17-22

AN ORDINANCE OF THE VILLAGE OF EAST DUNDEE, COOK AND KANE COUNTIES, ILLINOIS, AMENDING THE CODE OF ORDINANCES OF THE VILLAGE OF EAST DUNDEE REGARDING INAUGURATION OF THE VILLAGE PRESIDENT AND TRUSTEES

WHEREAS, the Village of East Dundee (the "*Village*") is a duly organized and validly existing home-rule municipality created in accordance with the Constitution of the State of Illinois of 1970 and the laws of the State; and,

WHEREAS, the Village pursuant to its home rule powers has the authority to exercise any power and perform any function pertaining to its government and affairs including the power to regulate for the protection of the public health, safety and welfare; and,

WHEREAS, pursuant to its home rule authority, the Village has determined that it is in the best interests of the health, safety and welfare of its residents to amend the Code of Ordinances of the Village of East Dundee to provide for the time of inauguration of a newly elected President and Village Trustees.

NOW, THEREFORE, BE IT ORDAINED by the President and Board of Trustees of the Village of East Dundee, Cook and Kane County, Illinois, as follows:

Section 1. That Title III Chapter 30 of the Code of Ordinances of the Village of East Dundee is hereby amended by deleting Section 30.01 and inserting in lieu thereof the following:

§ 30.01 Election.

The Board of Trustees shall be elected at a general election for a term of four years and shall serve until their successors are elected and have qualified. The inauguration of newly elected Trustees shall occur at the first regular or special meeting of the corporate authorities in the month of May following the election. Three of the six Trustees shall be elected in each odd-numbered year.

Section 2. That Title III Chapter 31 of the Code of Ordinances of the Village of East Dundee is hereby amended by deleting Section 31.15(A) and inserting in lieu thereof the following:

(A) *Election.* The Village President shall be elected at a general election for a four-year term and shall serve until his or her successor is elected and qualified as is provided by statute. The inauguration of the newly elected Village President shall occur at the first regular or special meeting of the corporate authorities in the month of May following the election.

Section 3. This Ordinance shall be in full force and effect upon its passage, approval, and publication in pamphlet form as provided by law.
