

ORDINANCE NUMBER 11 - 46

**ORDINANCE AMENDING TITLE IX, BUSINESS REGULATIONS,
CHAPTER 116, ALCOHOLIC BEVERAGES, BY ADDING A
SECTION 116.05(A)(15) CLASS G: BANQUET LICENSE AND
SECTION 116.05(B) NUMBER OF LICENSES TO BE PERMITTED**

WHEREAS, the Village of East Dundee is a home rule unit of local government under and pursuant to Section 6 of Article VII of the Constitution of the State of Illinois, has the authority to exercise any power and perform any function pertaining to its government and affairs, including but not limited to the power to regulate for the protection of the public health, safety, morals, and welfare; and

WHEREAS, the President and Board of Trustees of the Village of East Dundee having determined that it is in the best interests of the health, safety and welfare of the residents of the Village of East Dundee that **Title IX, Business Regulations, Chapter 116, Alcoholic Beverages, Section 116.05, Licenses**, by adding Subsection 116.05(A)(15) and 116.05(B).

NOW THEREFORE BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF EAST DUNDEE, COOK AND KANE COUNTIES, ILLINOIS, AS FOLLOWS:

Section One. That **Title IX, Business Regulations, Chapter 116, Alcoholic Beverages, Section 116.05, Licenses**, of the Village of East Dundee Code of Ordinances is hereby amended to add **Subsection 116.05(A)(15) to read** as follows:

116.05(A) Classification

§116.05(A)(15) Class G. Banquet license for the retail sales of alcoholic liquor on the specified premises for consumption on said premises only by patrons of the banquet hall facilities and does not allow the sale of alcoholic liquor to the general public.

Section Two. That **Title IX, Business Regulations, Chapter 116, Alcoholic Beverages, Section 116.05, Licenses**, of the Village of East Dundee Code of Ordinances is hereby amended to add Class G to **Subsection 116.05(B) to read**, as follows:

116.05(B) Number of Licenses to be Permitted

Classifications	Number Permitted
G	1

Section Three. Severability. If any section, paragraph or provision of this ordinance shall be held to be invalid or unenforceable for any reason, the validity or unenforceability of such section, paragraph or provision shall not affect any of the remaining provisions of this ordinance.

Section Four. Repeal. All ordinances, resolutions, motions or parts thereof in conflict herewith shall be and the same are hereby repealed.

Section Five. Publication. This ordinance shall be in full force and effect forthwith upon its adoption, approval and publication in pamphlet form as provided by law.
