

ORDINANCE NUMBER 07 - 27

**ORDINANCE AMENDING TITLE XV, LAND USAGE,
CHAPTER 156, SIGNS, TO ADD A NEW
SECTION 156.08, VILLAGE ELECTRONIC SIGN RENTAL**

WHEREAS, the Village of East Dundee is a home rule unit of local government under and pursuant to Section 6 of Article VII of the Constitution of the State of Illinois, has the authority to exercise any power and perform any function pertaining to its government and affairs, including but not limited to the power to regulate for the protection of the public health, safety, morals, and welfare; and

WHEREAS, the President and Board of Trustees of the Village of East Dundee having determined that it is in the best interests of the health, safety and welfare of the residents of the Village of East Dundee that **Title XV, Land Usage, Chapter 156, Signs**, be amended to include a new **Section 156.08, Village Electronic Sign Rental**.

NOW THEREFORE BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF EAST DUNDEE, COOK AND KANE COUNTIES, ILLINOIS, AS FOLLOWS:

Section One. That **Title XV, Land Usage, Chapter 156, Signs**, of the Village of East Dundee Code of Ordinances is hereby amended to include a new **Section 156.08, Village Electronic Sign Rental** as follows:

§ 156.08 VILLAGE ELECTRONIC SIGN RENTAL.

Businesses and non-profit organizations may rent space on the electronic sign owned and operated by the Village for purposes of advertising or other messages related to the operations of the entity as provided within the Village Annual Fee Schedule, with priority being given to messages pertaining to Village business and Village governmental boards, committees and commissions.

Section Two. Severability. If any section, paragraph or provision of this ordinance shall be held to be invalid or unenforceable for any reason, the invalidity or unenforceability of such section, paragraph or provision shall not affect any of the remaining provisions of this ordinance.

Section Three. Repeal. All ordinances, resolutions, motions or parts thereof in conflict herewith shall be and the same are hereby repealed.

Section Four. Publication. This ordinance shall be in full force and effect forthwith upon its adoption, approval and publication in pamphlet form as provided by law.
