

ORDINANCE NUMBER 04 - 20

**ORDINANCE AUTHORIZING THE DESIGNATION
OF FOURTH STREET AS ONE-WAY SOUTHBOUND**

WHEREAS, the Village of East Dundee is a home rule unit of local government under and pursuant to Section 6 of Article VII of the Constitution of the State of Illinois, has the authority to exercise any power and perform any function pertaining to its government and affairs, including but not limited to the power to regulate for the protection of the public health, safety, morals, and welfare; and

WHEREAS, the Village of East Dundee has the power to regulate vehicular traffic and specifically to designate any highway under its jurisdiction as a one-way highway pursuant to 625 ILCS 5/11-208(a)(4); and

WHEREAS, the corporate authorities of the Village of East Dundee have determined that it is advisable, necessary and in the public interest that the Village authorize the installation of yield signs at the intersections designated herein.

NOW THEREFORE BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF EAST DUNDEE, COOK AND KANE COUNTIES, ILLINOIS, AS FOLLOWS:

Section One. That the following local highway shall be designated one-way southbound as set forth below and that signs shall be placed thereon conforming to the State Manual and Specifications adopted by the Illinois Department of Transportation: Fourth Street between Barrington Avenue and Railroad Street.

Section Two. Severability. If any section, paragraph or provision of this ordinance shall be held to be invalid or unenforceable for any reason, the invalidity or unenforceability of such section, paragraph or provision shall not affect any of the remaining provisions of this ordinance.

Section Three. Repeal. All ordinances, resolutions, motions or parts thereof in conflict herewith shall be and the same are hereby repealed.

Section Four. Publication. This ordinance shall be in full force and effect forthwith upon its adoption, approval and publication in pamphlet form as provided by law.
