

Resolution No. 08-16

**A RESOLUTION OF THE VILLAGE OF EAST DUNDEE,
COOK AND KANE COUNTIES, ILLINOIS,
APPROVING A REVISED DESIGNATION OF THE EAST DUNDEE POLICE
DEPARTMENT LOBBY AS AN E-SALE SAFE ZONE**

WHEREAS, the Village of East Dundee, Cook and Kane Counties, Illinois (the “*Village*”) is a duly organized and validly existing home-rule municipality created in accordance with the Constitution of the State of Illinois of 1970 and the laws of the State; and,

WHEREAS, every year thousands of individuals meet face-to-face to complete online transactions, including, but not limited to, sales transacted through eBay and Craigslist; and,

WHEREAS, although the majority of these transactions are conducted without incident, a handful of high-profile crimes involving buyers or sellers being victimized have occurred nationwide; and,

WHEREAS, the President and Board of Trustees of the Village (the “*Corporate Authorities*”) have determined that it is in the best interests of the Village and the health, safety, morals and welfare of its residents to designate a certain area within the Village as a safe place that buyers and sellers can meet to complete online transactions, thereby reducing the chance that criminal activity will occur; and,

WHEREAS, on July 6, 2015, the Village adopted Resolution No. 52-15, which designated the lobby of the East Dundee Police Department, which was then located at 120 Barrington Avenue, East Dundee, Illinois, as an E-Sale Safe Zone; and,

WHEREAS, in or around June of 2016, the East Dundee Police Department shall move its facilities from 120 Barrington Avenue, East Dundee, Illinois, to 115 Third Street, East Dundee, Illinois; and,

WHEREAS, the Corporate Authorities have determined it to be in the best interest of the Village to repeal its Resolution No. 52-15 and adopt this resolution designating a new E-Sale Safe Zone.

NOW, THEREFORE, BE IT RESOLVED by the President and Board of Trustees of the Village of East Dundee, Cook and Kane Counties, Illinois, as follows:

Section 1. That Resolution No. 52-15, passed July 6, 2015, is hereby repealed.

Section 2. That the lobby of the East Dundee Police Department located at 115 Third Street, East Dundee, Illinois, is hereby designated as an E-Sale Safe Zone for individuals to utilize during normal business hours, 8:30 a.m. to 5:00 p.m. Monday through Friday, to complete online transactions.

Section 3. That this Resolution shall be in full force and effect from and after its passage and approval as provided by law.




