

ORDINANCE NUMBER 05 - 11

**ORDINANCE AMENDING ANNUAL FEE SCHEDULE,  
ESTABLISHING WATER & SEWER FEES  
FOR THE VILLAGE OF EAST DUNDEE**

**WHEREAS**, the Village of East Dundee is a home rule unit of local government under and pursuant to Section 6 of Article VII of the Constitution of the State of Illinois, has the authority to exercise any power and perform any function pertaining to its government and affairs, including but not limited to the power to regulate for the protection of the public health, safety, morals, and welfare; and

**WHEREAS**, the President and Board of Trustees of the Village of East Dundee having determined that it is in the best interests of the health, safety and welfare of the residents of the Village of East Dundee that the Annual Fee Schedule be amended.

**NOW THEREFORE BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF EAST DUNDEE, COOK AND KANE COUNTIES, ILLINOIS, AS FOLLOWS:**

**Section One.** That the Annual Fee Schedule of the Village of East Dundee is hereby amended by deleting and substituting in lieu of Chapter 51, Section 51.37(A), **Water User Charge** as follows:

Chapter 51 - Water Service (Rev. Ord. 95-5, 2/20/95)

**51.37(A) Water User Charge**

**WITHIN THE CORPORATE LIMITS:** (Rev. Ord. 84-20, 10/1/84; Ord. 87-8, 4/20/87; Ord. 89-21, 9/18/89; Ord. 91-03, 5/20/91; Ord. 95-12, 7/10/95)

**Residential & Commercial Rates**

Water per 1,000 gallons (within the corporate limits)    \$ 3.29

**Section Two:** That the Annual Fee Schedule of the Village of East Dundee is hereby amended by deleting and substituting in lieu of Chapter 53, Section 53.62(a) as follows:

Chapter 53 - Sewer Service

3. Wastewater User Charge; Section 53.62(a)

Residential & Commercial Rates  
Sewer per 1,000 gallons

\$ 2.80

**Section Three. Severability.** If any section, paragraph or provision of this resolution shall be held to be invalid or unenforceable for any reason, the invalidity or unenforceability of such section, paragraph or provision shall not affect any of the remaining provisions of this ordinance.

**Section Four. Repeal.** All ordinances, resolutions, motions or parts thereof in conflict herewith shall be and the same are hereby repealed.

**Section Five. Publication.** This ordinance shall be in full force and effect forthwith upon its adoption, approval and publication in pamphlet form as provided by law. Adopted this 18<sup>th</sup> day of April, 2005, pursuant to a roll call vote as follows:
