**ORDINANCE AMENDING TITLE XV: LAND USAGE, CHAPTER
157, ZONING, SECTIONS 157.050-157.055, GENERAL
REQUIREMENTS BY DELETING 157.050(B) AND REPLACING
ALL OF 157.050(F) AND INCORPORATING A TABLE OF
ALLOWABLE USES IN ITS PLACE**

WHEREAS, the Village of East Dundee is a home rule unit of local government under and pursuant to Section 6 of Article VII of the Constitution of the State of Illinois, has the authority to exercise any power and perform any function pertaining to its government and affairs, including but not limited to the power to regulate for the protection of the public health, safety, morals, and welfare; and

WHEREAS, The President and Board of Trustees have determined that it is necessary and desirable to make amendments to Residence Districts requirements under Section 157.050, General Requirements and to incorporate a Table of Allowable Uses to assist member of the general public in determining permitted and special uses in the various zoning districts of the Village of East Dundee; and

WHEREAS, A Table of Permitted Uses has been created which sets out the permitted and special uses in the various districts within the Village of East Dundee, said Table attached hereto as Attachment B.1; and

WHEREAS, the Planning and Zoning commission (hereinafter the "Commission") of the Village of East Dundee, pursuant to notice and pursuant to the East Dundee Code of Ordinances, held a public hearing on March 14, 2013 on the Village Initiated Text Amendment to Sec. 157.050-157.055 providing for a table and revisions to the allowable uses in all residence districts as set forth in Attachment B.1 and deleting 157.050(B)(2); and

WHEREAS, pursuant to said hearing, the Commission approved the amendments to 157.050-157.055 by a vote of 5 ayes, 0 naves and 2 absent.

WHEREAS, it is in the best interest of the Village to adopt a Table of Permitted Uses as set forth on Attachment B.1 in place of Title XV, Chapter 157, Zoning, Section 157.050 General Requirements with Attachment B.1.

NOW THEREFORE BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF EAST DUNDEE, KANE AND COOK COUNTIES, ILLINOIS, AS FOLLOWS:

Section One. The President and Board of Trustees hereby adopt the Table of Permitted Uses attached hereto as Attachment B.1, as a replacement for the current Section 157.050 of the Village of East Dundee Zoning Code, Title XV, Land Usage, Chapter 157, Zoning, and delete 157.050(B)(2).

Section Two. The Permitted, Special and Accessory uses in Sections 157.051(B)(C)(D) &(E) 157.052(B)(C)(D) &(E), 157.053(B)(C)(D)&(E), 157.054(B)(C)(D)&(E), 157.055(B)(C) &(D) are hereby replaced by sec. 157.050(F)(1) as set forth in Attachment B.1.

Section Two. Severability. If any section, paragraph or provision of this ordinance shall be held to be invalid or unenforceable for any reason, the invalidity or unenforceability of such section, paragraph or provision shall not affect any of the remaining provisions of this ordinance.

Section Three. Repeal. All ordinances, resolutions, motions or parts thereof in conflict herewith shall be and the same are hereby repealed.

Section Four. Publication. This ordinance shall be in full force and effect forthwith upon its adoption, approval and publication in pamphlet form as provided by law.

§ 157.050 GENERAL REQUIREMENTS

Delete 157.050(B)(2)

Replace sub-section (F) with the following:

(F) *Allowable use of land and buildings.*

(1) *Allowable uses table.* Permitted uses, special uses, accessory uses, and temporary uses in the business districts shall be as indicated on the following table. All other provisions of this chapter to the contrary notwithstanding, the Building Inspector shall determine whether a proposed use that is not specifically listed on the table is most similar to and compatible with one or more permitted uses, special uses, accessory uses, temporary uses, or prohibited uses and classify the use accordingly. Such determinations shall be recorded in writing and maintained on file in the Village Clerk's office.

(2) *Use-specific requirements.* The following uses shall comply with all listed requirements in addition to all other requirements specified in this chapter. In the event of a conflict between a requirement listed hereunder and that of another section of this chapter, the more restrictive requirement shall prevail.

(a) *Residential units above the first floor of any business.*

1. Shall comply with all other village ordinances including fire and life safety codes; and
2. Shall provide not less than one off-street parking space for each unit on the same lot as the residential use.

(b) *Vehicle Sales and Rental.*

1. Shall be located on parcels sufficiently large enough to fully comply with the following:
 - a. A minimum lot area of 40,000 square feet; and

b. The applicable perimeter landscaping and buffering requirements contained in § 158.04(D).

(c) *Public utility and public service use.*

1. Uses and facilities include: electric sub-stations and booster stations; telephone exchanges, repeater stations, micro-wave relay towers and stations, antenna towers and other outdoor equipment essential to the operation of the exchange in the interest of the public convenience; potable water well head stations, well separators, pumping stations, water filtration plants, reservoirs, and storage tanks and towers; natural gas regulator stations and similar above the ground facilities customarily used for the distribution, transmission or storage of natural gas as a part of the operation of a public utility; and satellite dishes as accessory to any of the above.

2. The use shall be located more than 200 feet from the boundary of a residential use.

3. Natural gas equipment and other installations may be in completely enclosed buildings or in the open, but along with electric substations and booster stations, must be completely enclosed behind two-inch or less mesh chainlink fence or equal, no less than six feet in height.
