

**ORDINANCE NUMBER 10 - 42**

**ORDINANCE AMENDING THE ANNUAL FEE SCHEDULE  
CHAPTER 31, FOIA REPORT, FOR THE VILLAGE OF EAST  
DUNDEE**

**WHEREAS**, the Village of East Dundee is a home rule unit of local government under and pursuant to Section 9 of Article VII of the Constitution of the State of Illinois, has the authority to exercise any power and perform any function pertaining to its government and affairs, including but not limited to the power to regulate for the protection of the public health, safety, morals, and welfare; and

**WHEREAS**, the corporate authorities of the Village of East Dundee have determined that it is in the best interests of the health, safety and welfare of the residents of the Village of East Dundee that the Annual Fee Schedule be amended.

**NOW THEREFORE BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF EAST DUNDEE, COOK AND KANE COUNTIES, ILLINOIS, AS FOLLOWS:**

**Section One.** That the Annual Fee Schedule of the Village of East Dundee is hereby amended as follows:

**CHAPTER 31 – FOIA REPORT**

- A. Black and White, Letter, or Legal Sized Copies:** First 50 pages are free
  - 1. Additional pages over 50 pages may not exceed 15 cents per page
- B. For Color or abnormal sized copies:** Actual cost for copying
- C. Electronic Copies:** Actual cost of the tape, CD, DVD, etc.

**Section Two. Severability.** If any section, paragraph or provision of this ordinance shall be held to be invalid or unenforceable for any reason, the validity or unenforceability of such section, paragraph or provision shall not affect any of the remaining provisions of this ordinance.

**Section Three. Repeal.** All ordinances, resolutions, motions or parts thereof in conflict herewith shall be and the same are hereby repealed.

**Section Four. Publication.** This ordinance shall be in full force and effect forthwith upon its adoption, approval and publication in pamphlet form as provided by law.
