

ORDINANCE NUMBER 08 - 59

**ORDINANCE AMENDING TITLE VII, TRAFIC CONTROL,
CHAPTER 71, TRAFFIC SCHEDULES, BY ADDING A NEW
SCHEDULE VIII**

WHEREAS, the Village of East Dundee is a home rule unit of local government under and pursuant to Section 9 of Article VII of the Constitution of the State of Illinois, has the authority to exercise any power and perform any function pertaining to its government and affairs, including but not limited to the power to regulate for the protection of the public health, safety, morals, and welfare; and

WHEREAS, the Village of East Dundee has the power to regulate vehicular traffic within the Village; and

WHEREAS, the corporate authorities of the Village of East Dundee have determined that it is advisable, necessary and in the public interest that the Village authorize the traffic control measure designated herein.

NOW THEREFORE BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF EAST DUNDEE, COOK AND KANE COUNTIES, ILLINOIS, AS FOLLOWS:

Section One. That Title VII, Traffic Control, Chapter 71, Traffic Schedules, is hereby amended to add a new Section VIII, Miscellaneous Traffic Control, as follows:

Section VIII:

<i>Street</i>	<i>Location</i>	<i>Traffic Control</i>	<i>Direction</i>
East Fourth Street	At Railroad Street	"Do Not Enter"	Northbound
Route 72	At Main Street Lot	"Do Not Enter"	West entrance
Route 72	At Main Street	"Entrance Only"	East Entrance
Route 72	At Main Street Lot	"Not an Exit"	
Roslyn Rd	At VanBuren	"Do Not Enter"	Eastbound

Section Two. Severability. If any section, paragraph or provision of this ordinance shall be held to be invalid or unenforceable for any reason, the invalidity or unenforceability of such section, paragraph or provision shall not affect any of the remaining provisions of this ordinance.

Section Three. Repeal. All ordinances, resolutions, motions or parts thereof in conflict herewith shall be and the same are hereby repealed.

Section Four. Publication. This ordinance shall be in full force and effect forthwith upon its adoption, approval and publication in pamphlet form as provided by law.
