

Ordinance No. 16-23

**AN ORDINANCE ESTABLISHING PARKING REGULATIONS IN
THE VILLAGE OF EAST DUNDEE, ILLINOIS**

WHEREAS, the Village of East Dundee (the "*Village*") is a duly organized and validly existing home-rule municipality created in accordance with the Constitution of the State of Illinois of 1970 and the laws of the State; and,

WHEREAS, Section 11-208(a)1 of the Illinois Vehicle Code (625 ILCS 5/11-208(a)1) authorizes a municipality to regulate the standing or parking of vehicles.

NOW, THEREFORE, BE IT ORDAINED by the President and Board of Trustees of the Village of East Dundee, Cook and Kane Counties, Illinois, as follows:

Section 1: That the Title of Chapter 72, "PARKING SCHEDULES", is hereby amended to read as "PARKING REGULATIONS" and "Schedule I. RESTRICTED PARKING. It shall be unlawful for an operator of a motor vehicle to park contrary to the following." is hereby deleted and a new Section 72.01 is hereby added to read as follows:

"Sec. 72.01 PARKING REGULATIONS

Except when necessary to avoid conflict with other traffic, or in compliance with the law or the directions of a police officer or official traffic-control device, no person shall park a vehicle in any of the following places:

and the list of streets, location, direction, special provisions, Ord. No. and Date Passed that followed are hereby readopted as part of Section 72.01 except as amended herein.

Section 2: That the list of parking regulations in Section 72.01 is hereby amended by deleting the following:

Street	Location	Side of Street	Special Provisions
"North River Street	From intersection with Jackson Street and northward for a distance of 43 feet	West	
North River	Between the north side of Railroad Street and the South side of Barrington Avenue	East	60 minute limit

Parking Lots 1 and 2	Between Railroad Street and Van Buren Street		No parking for more than 24 hours. No parking within 12 hours after a snowfall or three inches or more has occurred.
River Street	Between Main Street And Barrington Avenue	East and west sides	no parking for more than 24 hours
Village River Street	Route 72 parking lot		No parking for more than 24 hours. No parking within 12 hours after a snowfall or three inches or more has occurred. Parking between 2:00 AM and 6:00 PM is permitted.”

Section 3: That the parking regulations in Section 72.01 of the Code of the Village of East Dundee are hereby amended by adding the following:

Except when necessary to avoid conflict with other traffic, or in compliance with the law or the directions of a police officer or official traffic-control device, no person shall park a vehicle in any of the following places:

Street	Location	Side of Street	Special Provisions
“Main Street Parking Lot	West of River Street		24 hour limit, overnight parking allowed
River Street	Between Jackson Street and Hill Street	East side	3 hour parking from 7:00 AM to 5:00 PM
River Street	From Hill Street to Railroad Street	East side	3 hour parking from 7:00 AM to 5:00 PM for first 12 spaces
River Street	From Railroad Street to Barrington Avenue	East side	30 minute parking 7:00 AM to 5:00 PM first 2 spaces, and 3 hour parking 7:00 AM to 5:00 PM for the next 15 spaces

River Street	From Railroad Street to Barrington Avenue	West side	3 hour parking 7:00 AM to 5:00 PM first 16 spaces, and no overnight parking first 5 spaces
Hill Street Parking Lot	Between Hill Street and Railroad Street	South of Meier Street	24 hour limit, overnight parking allowed"

Section 4: This Ordinance shall be in full force and effect upon its passage, approval and publication as provided by law.
