

ORDINANCE NUMBER 08 - 04

**ORDINANCE AMENDING ANNUAL FEE SCHEDULE
FOR THE VILLAGE OF EAST DUNDEE**

WHEREAS, the Village of East Dundee is a home rule unit of local government under and pursuant to Section 6 of Article VII of the Constitution of the State of Illinois, has the authority to exercise any power and perform any function pertaining to its government and affairs, including but not limited to the power to regulate for the protection of the public health, safety, morals, and welfare; and

WHEREAS, the President and Board of Trustees of the Village of East Dundee having determined that it is in the best interests of the health, safety and welfare of the residents of the Village of East Dundee that **Chapter 51, Water Service**, of the Annual Fee Schedule be amended.

NOW THEREFORE BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF EAST DUNDEE, COOK AND KANE COUNTIES, ILLINOIS, AS FOLLOWS:

Section One. That the Annual Fee Schedule of the Village of East Dundee is hereby amended as follows:

CHAPTER 51 - WATER SERVICE

Outside Corporate Limits (Sec. 51.37(G)):

All rates for service to residential properties outside the corporate limits of the Village of East Dundee shall be 150 percent the rates set forth above. All rates for service to all other properties outside the corporate limits of the Village shall be 200 percent the rates set forth above, except, however, that the fee for a user who is a governmental body or a non-for-profit corporation shall be 100 percent of the fees set forth above. Nothing herein contained shall be construed to require or obligate the Village to permit such a connection.

Section Two. Severability. If any section, paragraph or provision of this ordinance shall be held to be invalid or unenforceable for any reason, the validity or unenforceability of such section, paragraph or provision shall not affect any of the remaining provisions of this ordinance.

Section Three. Repeal. All ordinances, resolutions, motions or parts thereof in conflict herewith shall be and the same are hereby repealed.

Section Four. Publication. This ordinance shall be in full force and effect forthwith upon its adoption, approval and publication in pamphlet form as provided by law.
