

ORDINANCE NUMBER 10 - 21

**ORDINANCE AMENDING TITLE XV, LAND USAGE,
CHAPTER 150, GENERAL PROVISIONS,
SECTION 150.01, ORGANIZATION,
BY ADDING SUBSECTION 150.01(G) TO SECTION 150.01**

WHEREAS, the Village of East Dundee is a home rule unit of local government under and pursuant to Section 6 of Article VII of the Constitution of the State of Illinois, has the authority to exercise any power and perform any function pertaining to its government and affairs, including but not limited to the power to regulate for the protection of the public health, safety, morals, and welfare; and

WHEREAS, the President and Board of Trustees of the Village of East Dundee having determined that it is in the best interests of the health, safety and welfare of the residents of the Village of East Dundee that **Title XV, Land Usage, Chapter 150, General Provisions, Section 150.01, Organization**, be amended by adding **Subsection 150.01(G)**.

NOW THEREFORE BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF EAST DUNDEE, COOK AND KANE COUNTIES, ILLINOIS, AS FOLLOWS:

Section One. That **Title XV, Land Usage, Chapter 150, General Provisions, Section 150.01, Organization**, of the Village of East Dundee Code of Ordinances is hereby amended by adding a **Subsection 150.01(G) to 150.01, Organization**, as follows:

' 150.01 ORGANIZATION

§150.01(G) Notwithstanding any provision to the contrary, any member of the Planning & Zoning Commission may forego any, or all, compensation to which they are otherwise entitled for any part of their term by notifying the Village Treasurer, in writing, of such an election, and the amount the Commissioner wishes to forego, the length of time the Commissioner wishes to forego such compensation, and the effective date of the election. Nothing in this Section shall be construed to prevent any Commissioner from rescinding the election to forego compensation, upon written notice to the Village Treasurer of their desire to rescind the election to forego compensation.

Section Two. Severability. If any section, paragraph or provision of this ordinance shall be held to be invalid or unenforceable for any reason, the validity or unenforceability of such section, paragraph or provision shall not affect any of the remaining provisions of this ordinance.

Section Three. Repeal. All ordinances, resolutions, motions or parts thereof in conflict herewith shall be and the same are hereby repealed.

Section Four. Publication. This ordinance shall be in full force and effect forthwith upon its adoption, approval and publication in pamphlet form as provided by law.
