ORDINANCE AMENDING TITLE III: ADMINISTRATION, CHAPTER 30 BOARD OF TRUSTEES, §30.13(C)

WHEREAS, the Village of East Dundee is a home rule unit of local government under and pursuant to Section 6 of Article VII of the Constitution of the State of Illinois, has the authority to exercise any power and perform any function pertaining to its government and affairs, including but not limited to the power to regulate for the protection of the public health, safety, morals, and welfare; and

WHEREAS, the President and Board of Trustees of the Village of East Dundee have determined that Title III, Chapter 30 Board of Trustees, §30.13(C) should be amended to reflect a starting time of 6;00 p.m.; and

WHEREAS, the President and Board of Trustees of the Village of East Dundee having determined that it is in the best interests of the health, safety and welfare of the residents of the Village of East Dundee to amend the starting time of the Committee of the Whole Meetings to hereafter commence at 6:00 p.m.

NOW THEREFORE BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF EAST DUNDEE, COOK AND KANE COUNTIES, ILLINOIS, AS FOLLOWS:

Section One. That Title III: Administration, Chapter 30 Board of Trustees, §30.13(C) shall be amended to read as follows:

30.13(C)

The Committee of the Whole shall meet on the second Monday of each month at the hour of **6:00 p.m.** The President may call such additional meetings of the Committee of the Whole as are required, pursuant to the notice requirements set forth in this chapter.

<u>Section Two</u>. Severability. If any section, paragraph or provision of this ordinance shall be held to be invalid or unenforceable for any reason, the validity or unenforceability of such section, paragraph or provision shall not affect any of the remaining provisions of this ordinance.

<u>Section Three</u>. Repeal. All ordinances, resolutions, motions or parts thereof in conflict herewith shall be and the same are hereby repealed.

<u>Section Four</u>. Publication. This ordinance shall be in full force and effect forthwith upon its adoption, approval and publication in pamphlet form as provided by law.
