

Ordinance No. 17-03

**AN ORDINANCE OF THE VILLAGE OF EAST DUNDEE, ILLINOIS,  
UPDATING THE CODE OF THE VILLAGE OF EAST DUNDEE RELATING TO  
THE POLICE DEPARTMENT**

**WHEREAS**, the Village of East Dundee (the "*Village*") is a duly organized and validly existing home-rule municipality created in accordance with the Constitution of the State of Illinois of 1970 and the laws of the State; and,

**WHEREAS**, the Village desires to update the section in the Code of the Village of East Dundee relating to the establishment of the Police Department.

**NOW, THEREFORE, BE IT ORDAINED** by the President and Board of Trustees of the Village of East Dundee, Cook and Kane County, Illinois, as follows:

**Section 1:** That the Code of the Village of East Dundee, as amended, be and is hereby amended by amending Subsection 32.04(C) to read as follows:

"(C) The Police Department shall consist of the Chief of Police and other full-time sworn officers including supervisory and police officers, and other employees of the Department including part-time police officers and civilian members as may be authorized and budgeted from time to time by the President and Board of Trustees."

**Section 2:** That Subsections 32.04(D)(3), 32.04(D)(4) and 32.04(J) of the Code of the Village of East Dundee be and are hereby repealed.

**Section 3:** That Subsection 32.04(E)(2) of the Code of the Village of East Dundee shall be amended to read as follows:

"(2) All full-time sworn members of the Police Department, except the Chief of Police, shall be appointed by the Board of Police Commissioners."

**Section 3:** That Subsection 32.04(G) of the Code of the Village of East Dundee shall be amended to read as follows:

"(G) Part-time police officers shall meet the following minimum hiring standards:

- (1) Must be a minimum of 21 years of age;
- (2) Must have received an Associate's Degree or have completed 48 hours in a semester system or 60 credit hours in a quarter system with a grade of C or better from an accredited college or university;
- (3) Must have successfully completed prior to hiring a certified Illinois Law Enforcement Training & Standards Board (ILETSB) certified basic 400 hour (or more, as designated by the ILETSB) Police Officer training academy program, which includes the ILETSB certified firearms training course, as required by the Illinois Compiled Statutes;

or have completed a comparable Police Officer training academy program in another state, which would be recognized and accepted by the ILETSB.; and

(4) Must possess a valid Illinois driver's license."

**Section 4:** That this ordinance shall be in full force and effect from and after its passage, approval and publication in pamphlet form as provided by law.
