

ORDINANCE NUMBER 03 - 10

**ORDINANCE VACATING A PORTION OF
A STREET COMMONLY KNOWN AS
VALLEY VIEW ROAD, EAST DUNDEE, ILLINOIS**

WHEREAS, the corporate authorities of the Village of East Dundee (herein the "Village") have determined that the public interest will be served by vacating a portion of the public street within the corporate limits; and

WHEREAS, the portion of such street commonly known as "Valley View Road" to be vacated is set forth in the attached Exhibit "A"; and

WHEREAS, the adjoining property owner is Community School District 300 of Cook, DeKalb, Kane and McHenry Counties, Illinois, a governmental entity; and

WHEREAS, the corporate authorities of the Village have determined that it is in the public interest that such vacation take place without compensation; and

WHEREAS, the Village has determined that there are no public service facilities in the portion of such street to be vacated.

NOW THEREFORE BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF EAST DUNDEE, KANE AND COOK COUNTIES, ILLINOIS, AS FOLLOWS:

Section One. That pursuant to Illinois Revised Statutes, 65 ILCS 5/11-91-1, the Village, by a vote of three-fourths of the trustees now holding office, does hereby vacate that portion of Valley View Road set forth in Exhibit "A," conveying all its right, title, and interest to Community School District 300 of Cook, DeKalb, Kane, and McHenry Counties, Illinois, by such vacation.

Section Two. Severability. If any section, paragraph or provision of this ordinance shall be held to be invalid or unenforceable for any reason, the invalidity or unenforceability of such section, paragraph or provision shall not affect any of the remaining provisions of this ordinance.

Section Three. Repeal. All ordinances, resolutions, motions or parts thereof in conflict herewith shall be and the same are hereby repealed.

Section Four. Publication. This ordinance shall be in full force and effect forthwith upon its adoption, approval and publication in pamphlet form as provided by law.

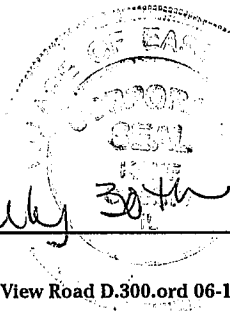
