

RESOLUTION NUMBER 31 - 09

RESOLUTION AUTHORIZING AN INCENTIVE PROGRAM FOR THE
PURCHASE OF MOTOR VEHICLES IN EAST DUNDEE

WHEREAS, the Village of East Dundee is a home rule unit of local government under and pursuant to Section 6 of Article VII of the Constitution of the State of Illinois, has the authority to exercise any power and perform any function pertaining to its government and affairs, including but not limited to the power to regulate for the protection of the public health, safety, morals, and welfare; and

WHEREAS, the current economic climate has resulted in reduced motor vehicles sales not only locally but throughout the county, as evidenced by the closure of dealerships, and the problems besetting the major domestic car manufactures; and

WHEREAS, motor vehicle sales represent a very significant portion of the retail sales tax base in East Dundee; and

WHEREAS, the Village is looking at ways to encourage and to promote the sales of motor vehicles in East Dundee, and promote ancillary businesses at the same time.

NOW THEREFORE BE IT RESOLVED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF EAST DUNDEE, COOK AND KANE COUNTIES, ILLINOIS, AS FOLLOWS:

Section One. That the Village of East Dundee hereby authorizes the issuance of gas cards to the purchasers of motor vehicles in East Dundee.

Section Two. A \$100.00 gas card shall be provided to the purchaser of a new motor vehicle, and a \$50.00 gas card for the purchase of a used motor vehicle of \$5,000 or more.

Section Three. This program shall be limited to the sales of motor vehicles from duly licensed motor vehicle businesses in East Dundee, and not for the private sale of motor vehicles from one individual to another.

Section Four. This program shall run from July 1st, 2009 through July 31st, 2009 unless otherwise extended by the Village Board.

Section Five. Gas Cards shall be purchased only from the motor fuel retailers within the East Dundee Business Development District as presently in effect or as may be amended by the Village of East Dundee.

Section Six. Severability. If any section, paragraph or provision of this resolution shall be held to be invalid or unenforceable for any reason, the invalidity or unenforceability of such section, paragraph or provision shall not affect any of the remaining provisions of this resolution.

Section Seven. Repeal. If any section, paragraph, clause, or provision of this Resolution shall for any reason be held to be invalid or unenforceable, the invalidity or unenforceability of such section, paragraph, clause, or provision shall not affect any of the remaining provisions of this Resolution.

Section Eight. Publication. This resolution shall be in full force and effect forthwith upon its adoption, approval and publication in pamphlet form as provided by law.
