

**ORDINANCE NUMBER 09 - 13**

**ORDINANCE REMOVING CHAPTER 31, SECTION 16 (E) FROM  
THE EAST DUNDEE VILLAGE CODE**

**WHEREAS**, the Village of East Dundee is a home rule unit of local government under and pursuant to Section 6 of Article VII of the Constitution of the State of Illinois, has the authority to exercise any power and perform any function pertaining to its government and affairs, including but not limited to the power to regulate for the protection of the public health, safety, morals, and welfare; and

**WHEREAS**, Title III Administration, Chapter 31, Section 16 (E) of the East Dundee Village Code prescribes specific duties and responsibilities for the office of Village Clerk; and

**WHEREAS**, said duties are reflective of practices no longer assigned to the Village Clerk, including the accepting payments and other financial matters which are now handles by professional staff under the supervision of the Finance Manager; and

**WHEREAS**, the Village Board has determined that said practices are no longer necessary to be included within the official duties and responsibilities of the office of Village Clerk.

**NOW THEREFORE BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF EAST DUNDEE, COOK AND KANE COUNTIES, ILLINOIS, AS FOLLOWS:**

**Section One.** That the Village of East Dundee adopts and approves the removal of Chapter 31, Section 16 (E) Accounts in its entirety from the East Dundee Village Code, a copy of which is attached hereto and made a part hereof.

**Section Two. Severability.** If any section, paragraph or provision of this ordinance shall be held to be invalid or unenforceable for any reason, the validity or unenforceability of such section, paragraph or provision shall not affect any of the remaining provisions of this ordinance.

**Section Three. Repeal.** All ordinances, resolutions, motions or parts thereof in conflict herewith shall be and the same are hereby repealed.

**Section Four. Publication.** This ordinance shall be in full force and effect forthwith upon its adoption, approval and publication in pamphlet form as provided by law.
