

**ORDINANCE NUMBER 02 - 02**

**AMENDMENT TO CHAPTER 6, WATER SERVICE,  
SECTION 6.10(b), WATER USE RESTRICTIONS  
AND PENALTY, OF THE MUNICIPAL CODE  
OF THE VILLAGE OF EAST DUNDEE**

**WHEREAS**, the Village of East Dundee as a non-home rule unit has been granted such statutory powers pursuant to the Illinois Constitution either expressly or as may be impliedly necessary to the accomplishment of the intent of the duties expressly conferred on it by law; and

**WHEREAS**, the corporate authorities of the Village of East Dundee believe that the public health, safety, morals and welfare of the residents of the Village of East Dundee and those persons who enter the territorial jurisdiction of the Village would best be served by making the following amendment to the municipal code.

**NOW THEREFORE BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF EAST DUNDEE, KANE COUNTY, ILLINOIS, AS FOLLOWS:**

Section One. That the Municipal Code of the Village of East Dundee, Chapter 6, **Water Service**, Section 6.10(b), **Emergency Limitations - Water** be amended to read as follows:

- (b) **Emergency Limitations - Water**. The Village President shall have the authority by proclamation to restrict the use of water in the Village in order to ensure adequate water supplies.
  - (1) When such watering restrictions are in force, all outside use of water shall be limited to between the hours of 6:00 a.m. and 10:00 a.m. each morning, and between 6:00 p.m. and 10:00 p.m. each evening. Outside use of water for any purpose shall

be prohibited at all other hours when such limitations are in effect. The term "outside use of water" as used in this section includes but is not limited to the watering of lawns and outside vegetation, filling of swimming pools, washing cars, and the like. Such restriction on water usage shall be enforced as follows:

- (i) All residential, commercial, industrial, and institutional properties designated by a street address with an even number shall be permitted to use water for lawn purposes on even numbered days of the month only.
- (ii) All residential, commercial, industrial, and institutional properties designated by a street address with an odd number shall be permitted to use water for lawn purposes on odd numbered days of the month only.
- (iii) Any exceptions to the above restrictions shall require a special Village permit. Such exceptions shall only be authorized by the Superintendent of Public Works or the Village Board.

(2) **Posting of Restrictions.** Signage placed within the Village announcing the watering restrictions shall have the following meanings:

- (i) **Green:** Unrestricted watering.
- (ii) **Yellow:** The above described even/odd days restrictions apply.
- (iii) **Red:** All outside water use is strictly prohibited.

(3) **Posting Locations.** Signage for watering shall be posted at the following major intersections:

(4) **Penalty.** Any person, firm, or corporation violating any of the above provisions of this Section 6.10(b) shall be subject to a fine not less than \$50 nor more than \$750 for each such offense. Each day that such violation exists shall constitute a separate offense.

**Section Two.** That the Municipal Code of the Village of East Dundee, Chapter 6, **Water Service**, Section 6.14(b) be amended by deleting the third sentence thereof. Such ordinance as amended shall read as follows:

- (b) **Manner of Billing.** Said rates or charges for service shall be payable bi-monthly depending upon the classification of service for which bills are rendered. The owner of the premises, the occupant thereof, and the user of the service shall be jointly and severally liable to pay for the service to such premises and the service furnished to the premises by the Village only upon the condition that the owner of the premises, occupant, and user of the services are jointly and severally liable therefor to the Village.

All water bills are due and payable 14 days after being sent out.

**Section Three. Severability.** If any section, paragraph or provision of this resolution shall be held to be invalid or unenforceable for any reason, the invalidity or unenforceability of such section, paragraph or provision shall not affect any of the remaining provisions of this ordinance.

**Section Four. Repeal.** All ordinances, resolutions, motions or parts thereof in conflict herewith shall be and the same are hereby repealed.

**Section Five. Publication.** This ordinance shall be in full force and effect forthwith upon its adoption, approval and publication in pamphlet form as provided by law.





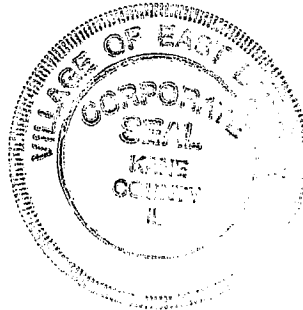

#1 Elgin Ave.- 56' North from Village Entrance sign & 7' east from the east side of Elgin Ave.

#2 Water & Lincoln- 3' West from the west side of water & 75' South From Village of East Dundee sign

#3 Water & Jackson- 116' North of Jackson & 1' East form East side of the road of Water

#4 South River & Main- 75' South of Main st & 3' East of River on East side of the road

#5 S. VanBuren & Johnson- 3' West of VanBurn on west side of the road & 106' North of Johnson

#6 N. VanBurn & Main- 4' East of VanBurn on East Side of the road & 14' North of Main

#7 N. VanBurn & Wilmette- 3' West of VanBuren on West side of the road & 122' South of Wilmette

#8 Rock Rd & Rt. 72- 8' East of Rock Rd. on East side of Rock & 124' South of Rt. 72

#9 Barrington Ave. & Rt.68- 19' West of Frontage Rd. & 4' North of Barrington Ave. on North side of the road

#10 Aldis & Rt.68- 4' West of Aldis on West side of road & 125' South of Rt.68

#11 Park & Rt.25- 3' North of Park on North side & 184' West of Aberdeen

#12 Park & Rt. 68- On West side of Park, 4' West Linden & 24' South of Park

#13 Howard & Main St- 3' East of Howard on East side of Howard & 54' North of Rt. 72

#14 King & Main- 4' West of King on West side & 45' North of Springwood

#15 Prairie Lakes- 6' East of Prairie Lake Rd on East side & 145' North of Rt. 68

#16 Balmoral & Rt. 25- 38' East of Rt. 25 & 3' South from Balmoral on East side of the road
