

**ORDINANCE NUMBER 05 - 09**

**ORDINANCE RENAMING STREETS  
WITHIN THE VILLAGE OF EAST DUNDEE  
TO CONFORM WITH THE UNITED  
STATES POSTAL SERVICE STREET NAME LIST**

**WHEREAS**, the Village of East Dundee is a home rule unit of local government under and pursuant to Section 6 of Article VII of the Constitution of the State of Illinois, has the authority to exercise any power and perform any function pertaining to its government and affairs, including but not limited to the power to regulate for the protection of the public health, safety, morals, and welfare; and

**WHEREAS**, the corporate authorities of the Village of East Dundee (herein the "Village") have determined that certain street names must be changed to correspond to the form of those names in the national database used by the United States Postal Service.

**NOW THEREFORE BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF EAST DUNDEE, KANE AND COOK COUNTIES, ILLINOIS, AS FOLLOWS:**

**Section One.** That the following list of street names as they presently appear on the records of the Village of East Dundee be amended as set forth below:

**CURRENT STREET NAME**

Bramer Avenue  
First Street  
Second Street  
Third Street  
Fourth Street

**AMENDED STREET NAME**

Bramer Street  
E. 1<sup>st</sup> Street  
E. 2<sup>nd</sup> Street  
E. 3<sup>rd</sup> Street  
E. 4<sup>th</sup> Street

**Section Two. Severability.** If any section, paragraph or provision of this ordinance shall be held to be invalid or unenforceable for any reason, the invalidity or unenforceability of such section, paragraph or provision shall not affect any of the remaining provisions of this ordinance.

**Section Three. Repeal.** All ordinances, resolutions, motions or parts thereof in conflict herewith shall be and the same are hereby repealed.

**Section Four. Publication.** This ordinance shall be in full force and effect forthwith upon its adoption, approval and publication in pamphlet form as provided by law.
