

ORDINANCE NUMBER 12 - 73

**ORDINANCE AMENDING ANNUAL FEE SCHEDULE
FOR THE VILLAGE OF EAST DUNDEE**

WHEREAS, the Village of East Dundee is a home rule unit of local government under and pursuant to Section 9 of Article VII of the Constitution of the State of Illinois, has the authority to exercise any power and perform any function pertaining to its government and affairs, including but not limited to the power to regulate for the protection of the public health, safety, morals, and welfare; and

WHEREAS, the President and Board of Trustees of the Village of East Dundee have created two (2) additional classes of liquor license; and

WHEREAS, the President and Board of Trustees of the Village of East Dundee believe it to be in the best interest of the citizens of the Village of East Dundee to amend their annual fee schedule to reflect that a licensee who requires or desires more than one liquor license to pay a reduced fee for the second license; and

WHEREAS, the President and Board of Trustees of the Village of East Dundee having determined that it is in the best interests of the health, safety and welfare of the residents of the Village of East Dundee that the Annual Fee Schedule be amended to add a new Section 4, Fee for Additional License.

NOW THEREFORE BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF EAST DUNDEE, COOK AND KANE COUNTIES, ILLINOIS, AS FOLLOWS:

Section One. That the Annual Fee Schedule of the Village of East Dundee is hereby amended to add a Section 4 to fee schedule for Chapter 116 – Alcoholic Beverages, as set forth below:

CHAPTER 116 B ALCOHOLIC BEVERAGES

4. Fee for Additional License \$1000.00

A licensee who desires, qualifies for, and receives more than one class of license for any one establishment shall pay the full cost of the license having the highest fee, and the additional fee for the second license as set forth

above.

Section Two. Severability. If any section, paragraph or provision of this ordinance shall be held to be invalid or unenforceable for any reason, the validity or unenforceability of such section, paragraph or provision shall not affect any of the remaining provisions of this ordinance.

Section Three. Repeal. All ordinances, resolutions, motions or parts thereof in conflict herewith shall be and the same are hereby repealed.

Section Four. Publication. This ordinance shall be in full force and effect forthwith upon its adoption, approval and publication in pamphlet form as provided by law.
