

ORDINANCE NUMBER 02 - 12

**ORDINANCE GRANTING VARIATION FOR THE
PROPERTY COMMONLY KNOWN AS
421 EAST MAIN STREET, EAST DUNDEE, ILLINOIS**

WHEREAS, the Zoning Board of the Village of East Dundee, pursuant to notice, held a hearing on July 11, 2002, on Petition No. PZ-02-06-07 requesting a variation for the property commonly known as 421 East Main Street, East Dundee, Illinois, as follows: A variation to move the Citgo pricing sign to a location that would encroach 14.5 feet into the required 15.0 foot setback; and

WHEREAS, pursuant to said hearing, the Zoning Board of Appeals made Findings of Facts and Recommendations from Findings and Hearing by a vote of 7 ayes, 0 nays, and 2 absent, recommended that a variation be granted to permit the requested variation to move the Citgo pricing sign to a location that would encroach 14.5 feet into the required 15.0 foot setback.

NOW THEREFORE BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF EAST DUNDEE, KANE AND COOK COUNTIES, ILLINOIS, AS FOLLOWS:

Section One. That the Findings of Fact of the Zoning Board of Appeals are hereby approved and adopted and that a variation be granted for the property commonly known as 421 East Main Street, East Dundee, to permit the relocation of the Citgo pricing sign to a location that will encroach 14.5 feet into the required 15.0 foot front yard setback.

Section Two. Severability. If any section, paragraph or provision of this ordinance shall be held to be invalid or unenforceable for any reason, the invalidity or unenforceability of such section, paragraph or provision shall not affect any of the remaining provisions of this ordinance.

Section Three. Repeal. All ordinances, resolutions, motions or parts thereof in conflict herewith shall be and the same are hereby repealed.

Section Four. Publication. This ordinance shall be in full force and effect forthwith upon its adoption, approval and publication in pamphlet form as provided by law.
