

## ORDINANCE NUMBER 05 - 01

### ORDINANCE AMENDING § 32.07 BOARD OF FIRE AND POLICE COMMISSIONERS FOR THE VILLAGE OF EAST DUNDEE

**WHEREAS**, the Village of East Dundee is a home rule unit of local government under and pursuant to Section 6 of Article VII of the Constitution of the State of Illinois, has the authority to exercise any power and perform any function pertaining to its government and affairs, including but not limited to the power to regulate for the protection of the public health, safety, morals, and welfare; and

**WHEREAS**, the President and Board of Trustees of the Village of East Dundee having determined that it is in the best interests of the health, safety and welfare of the residents of the Village of East Dundee that the Annual Fee Schedule be amended.

**NOW THEREFORE BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF EAST DUNDEE, COOK AND KANE COUNTIES, ILLINOIS, AS FOLLOWS:**

**Section One.** That Title III, **Administration**, Chapter 32, **Departments, Commissions and Other Organizations**, Section 32.07, **Board of Fire and Police Commissioners** of the Village of East Dundee Code of Ordinances is hereby amended by adding sections (D)(4) and (D)(5) as follows:

- (D) (4) The Board of Fire and Police Commissioners shall give preference for original appointment to persons designated in 65 ILCS 5/10-2.1-8 Original appointments; Preferences; Limitation, whose names appear on any register of eligibles resulting from an examination for original entrance in the classified service of the fire and police departments by adding to the final grade average which they receive or will receive as the result of any examination held for original entrance, 2.5 points for an associates degree in the field of law enforcement

or criminal justice and 5 points for a bachelor's degree from an accredited college or university. In all other respects preferences shall be as set forth in statute.

(D)(5) That the Board of Fire and Police Commissioners shall charge a fee for processing each application as may be set from time to time in the Annual Fee Schedule.

**Section Two.** That the Annual Fee Schedule is hereby amended by adding Chapter 32, **Departments, Commissions and Other Organizations**, Section 32.07, **Board of Fire and Police Commissioners** as follows:

**Section Three. Severability.** If any section, paragraph or provision of this ordinance shall be held to be invalid or unenforceable for any reason, the invalidity or unenforceability of such section, paragraph or provision shall not affect any of the remaining provisions of this ordinance.


**Section Four. Repeal.** All ordinances, resolutions, motions or parts thereof in conflict herewith shall be and the same are hereby repealed.

**Section Five. Publication.** This ordinance shall be in full force and effect forthwith upon its adoption, approval and publication in pamphlet form as provided by law.
