**A RESOLUTION OF THE VILLAGE OF EAST DUNDEE,
COOK AND KANE COUNTIES, ILLINOIS, TO AUTHORIZE THE PURCHASE OF
BRICK PAVERS IN THE AMOUNT OF \$35,000.00 FROM LURVEY LANDSCAPE
SUPPLY**

WHEREAS, the Village of East Dundee, Cook and Kane Counties, Illinois (the "Village") is a duly organized and validly existing home-rule municipality created in accordance with the Constitution of the State of Illinois of 1970 and the laws of the State; and,

WHEREAS, pursuant to the Downtown Redevelopment Street Improvement Contract, the Village is responsible for purchasing brick pavers for the street improvement project.

NOW, THEREFORE, BE IT RESOLVED by the President and Board of Trustees of the Village of East Dundee, Cook and Kane Counties, Illinois, as follows:

Section 1. That the bidding requirements are waived pursuant to Section 34.01(A) of the Code of the Village of East Dundee.

Section 2. That the Village Administrator is hereby authorized enter into a contract with Lurvey Landscape Supply for the purchase of brick pavers in an amount not to exceed \$35,000.00.

Section 3. That this Resolution shall be in full force and effect from and after its passage and approval according to law, and waiving the bidding requirements by a two-thirds vote of the members of the Village Board of Trustees.

Per the downtown redevelopment street improvement contract the Village is responsible for the brick paver purchase. The Village took the route of not including the purchase of pavers within the construction contract, so the Village could control the selection process and avoid markup of the final product. The brick pavers on this project are planned to infill most of the crosswalks and parking islands. We have selected a brick that is pretreated to help to prevent salt damage. The color will be a three brick blend. A field mock-up will be performed to determine the final order.

The brick manufacturer is a good size company but only has one distributor located in southern Wisconsin and Illinois. Due the limited local supply, the purchase will be considered a sole source purchase. Budget for bricks was set at \$50,000. Based off the current square footage estimates the Village is looking at a purchase of \$33,502.20. I'm requesting a purchase order in the amount of \$35,000. The extra will cover any bricks needed for repair stock and expansion of current project areas.

Please let me know if any additional questions about the brick pavers. I would like to get this purchase order at your earliest convenience so we can keep the project moving forward.
