

RESOLUTION 03 - 2000

**RESOLUTION AMENDING THE EMPLOYEE
PERSONNEL MANUAL OF THE VILLAGE OF EAST DUNDEE**

WHEREAS, the Village of East Dundee has determined that it is in the public interest to amend its Personnel Manual in the manner set forth herein.

NOW THEREFORE BE IT RESOLVED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF EAST DUNDEE, COOK AND KANE COUNTIES, ILLINOIS.

Section One. That the Employee Personnel Manual, General Benefits, Section 6.9, LONGEVITY PAY, B. Full Time Personnel, be amended as follows:

B. Full Time Personnel.

30 days to 1 years service:	\$ 50.00
2 years to 5 years service:	\$ 75.00
Over 5 years service:	\$100.00

(Revised effective January 3, 2000)

Section Two. That the Employee Personnel Manual, Holiday, Vacation, Sick Leave, Leaves of Absence, Section 5.3, Vacation Pay, Section F, first paragraph, be amended as follows:

Completion of 1 year of service through 6 years service (5 of the 10 days to be accrued may be utilized after the first 6 months of service, but will be charged against the 10 days earned upon completion of the first year of service, and only upon authorization by the Department Head and the Village Administrator). 10 days (8 days per 10 hour shift)

Section Three. Severability. If any section, paragraph or provision of this resolution shall be held to be invalid or unenforceable for any reason, the invalidity or

unenforceability of such section, paragraph, or provisions shall not affect any of the remaining provisions of this ordinance.

Section Four. Publication. That a full, true and complete copy of this resolution shall be published within 10 days after passage in pamphlet form by authority of the Board.

Section Five. Repeal. All resolutions or parts thereof in conflict herewith be and the same are hereby repealed and this resolution shall be in full force and effect forthwith upon its adoption, approval and publication as provided by law.



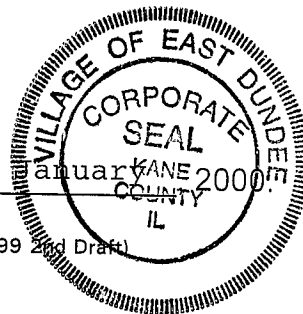
