BEING AN ORDINANCE MAKING APPROPRIATIONS FOR CORPORATE PURPOSES FOR THE FISCAL YEAR MAY 1, 1972, THROUGH APRIL 30, 1973.

BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF EAST DUNDEE, KANE COUNTY, ILLINOIS:

LEVY ORDINANCE

Being an Ordinance providing for the levy and assessment of taxes for the fiscal year 1972-1973 for the Village of East Dundee, Kane County, Illinois.

BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF EAST DUNDEE, KANE COUNTY, ILLINOIS, that:

A tax for the following sums of money, or as much thereof as may be authorized by law, is hereby levied for the purposes specified in Appropriation Ordinance 72-1 against all taxable property in the Village of East Dundee, Kane County, Illinois, for the fiscal year commencing on the 1st day of May, 1972, and ending on the 30th day of April, 1973.

WHEREAS, the land described on Exhibit "A" attached hereto and made a part of this Ordinance (hereafter called "Land") is situated upon the border but within the boundary of the Village of East Dundee; and

WHEREAS, the Land is not laid out into multiple lots or blocks; and

WHEREAS, the owners of record of the Land, GREG D. BESINGER and MARY BESINGER, his wife, have filed a written petition requesting that the Land be disconnected from the Village of East Dundee, and said petition has been on file with the clerk of the Village of East Dundee for over thirty days prior to the date hereof; and

WHEREAS, said petition was accompanied with a certificate of the County Clerk of Kane County showing all taxes or assessments due up to the time of the filing of said petition to be fully paid.

NOW, THEREFORE:

BE IT ORDAINED BY THE PRESIDENT AND THE  
BOARD OF TRUSTEES OF THE VILLAGE OF EAST  
DUNDEE:

1. That the Land described on Exhibit "A" attached hereto and made a part of this Ordinance be and the same is hereby disconnected from the Village of East Dundee.

2. That the clerk of the Village shall certify a copy of this Ordinance and cause the same to be filed for recordation in the office of the Recorder of Deeds of Kane County, Illinois and with the County Clerk of Kane County within ninety days after the

enactment hereof.

3. That this Ordinance shall be and become effective upon its passage and approval.

That part of the Northeast quarter of Section 22, Township 42 North, Range 8, East of the Third Principal Meridian described as follows: Beginning at the point of intersection of the Easterly line of Valley View Road with the Southerly line of North Lake Parkway as said streets were established on the plat of Section one First Addition to Lake Lodge Estates; thence North  $77^{\circ}30'$  West along the Southerly line of said North Lake Parkway 10.38 feet; thence Northwesterly along said Southerly line, being along a curve to the left having a radius of 211.64 feet, a distance of 60.80 feet, to the Northeast corner of Estate 1 in Block 8 of said Section one First Addition to Lakewood Lodge Estates; thence South  $0^{\circ}30'$  West along the Easterly line of said Estate to 21.85 feet to an angle in said Easterly line; thence South  $8^{\circ}02'$  West along said Easterly line 350 feet to the Southeast corner of said Estate 1; Thence North  $88^{\circ}34'$  East along the extension of the Southerly line of said Estate one 384 feet more or less to the Westerly line extended Southerly of Center Drive; thence Northerly along the extension of and the Westerly line of said Center Drive 513.12 feet to the Southerly line of North Lake Parkway as established on the plat of First Addition to Unit 8 of Golf View Highlands; thence Westerly along said Southerly line being along a curve to the right having a radius of 482.527 feet to the West line of the Northeast quarter of said Northeast quarter; thence Northwesterly 128 feet more or less to the point of beginning (except the Easterly 150 feet measured at right angles to the Easterly line thereof) in the Village of Carpentersville and East Dundee, Kane County, Illinois.

ORDINANCE 72-5

AN ORDINANCE AMENDING CHAPTER 28 OF THE MUNICIPAL CODE OF THE VILLAGE OF EAST DUNDEE, ILLINOIS, CONCERNING WATER AND SEWER SERVICE.

BE IT ORDAINED by the President and Board of Trustees of the Village of East Dundee, Kane County, Illinois, as follows:

1. That this amendment to the above-mentioned ordinance shall in no way revoke or affect any of the ordinances relative to Chapter 28 other than those which it displaces.

2. (a) That the second paragraph of Article II, Section 9., of Chapter 28 of the "Municipal Code of the Village of East Dundee, Illinois" be and the same is hereby amended to read:

"All applicants shall be charged the cost thereof as herein fixed and pay the same at the time the application herein provided for is made, as follows:

b. Multiple Unit residences or motels:

(b) That Article II, Section 9., of Chapter 28 is hereby amended in that the sentence "For connection to a sewer main, the fee shall be \$75.00" is hereby deleted from said Section 9.

3. That Article III, Section 1., of Chapter 28 of the "Municipal Code of the Village of East Dundee, Illinois" be and the same is hereby amended to read "One Hundred and Fifty Dollars (\$150.00) for a One Family residence", in lieu of "Seventy-five Dollars (\$75.00)".

4. That this Ordinance shall be in full force and effect from and after its passage as provided by law.
