

ORDINANCE NUMBER 04 - 03

**ORDINANCE GRANTING A VARIATION
FOR THE PROPERTY COMMONLY KNOWN AS
207 SOUTH VAN BUREN STREET,
EAST DUNDEE, ILLINOIS**

WHEREAS, the Planning and Zoning Commission (herein the "Commission") of the Village of East Dundee, pursuant to notice, held a hearing on January 8, 2004, on Petition No. P/Z-03-12-11 requesting a variation for the property commonly known as 207 South Van Buren Street, East Dundee, Illinois, for the following:

Variation sought:

A variation for the Northerly 27.50 feet of Lot 7 and all of Lot 8 to build across a platted lot line.

WHEREAS, pursuant to said hearing, the Commission adopted specific Findings of Fact concerning the application of zoning standards and variation standards for this subject property by a vote of 8 ayes, 0 nays, and 0 absent and recommended that the variation be granted.

NOW THEREFORE BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF EAST DUNDEE, KANE AND COOK COUNTIES, ILLINOIS, AS FOLLOWS:

Section One. That the Findings of Fact of the Commission are hereby approved and adopted and that the variation approved by the Commission pursuant to Petition No. P/Z 03-12-11 for a variation for the Northerly 27.50 feet of Lot 7 and all of Lot 8 to build across a platted lot line be granted for the property commonly known as 207 South Van Buren Street, East Dundee, Illinois.

Section Two. Severability. If any section, paragraph or provision of this ordinance shall be held to be invalid or unenforceable for any reason, the invalidity or unenforceability of such section, paragraph or provision shall not affect any of the remaining provisions of this ordinance.

Section Three. Repeal. All ordinances, resolutions, motions or parts thereof in conflict herewith shall be and the same are hereby repealed.

Section Four. Publication. This ordinance shall be in full force and effect forthwith upon its adoption, approval and publication in pamphlet form as provided by law.
