

ORDINANCE NUMBER 03 - 05

**ORDINANCE AMENDING ANNUAL FEE SCHEDULE,
ESTABLISHING WATER & SEWER FEES
FOR THE VILLAGE OF EAST DUNDEE**

WHEREAS, the Village of East Dundee as a non-home rule unit has been granted such statutory powers pursuant to the Illinois Constitution either expressly or as may be impliedly necessary to the accomplishment of the intent of the duties expressly conferred on it by law; and

WHEREAS, WHEREAS, the President and Board of Trustees of the Village of East Dundee having determined that it is in the best interests of the health, safety and welfare of the residents of the Village of East Dundee that the Annual Fee Schedule be amended.

NOW THEREFORE BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF EAST DUNDEE, COOK AND KANE COUNTIES, ILLINOIS, AS FOLLOWS:

Section One. That the Annual Fee Schedule of the Village of East Dundee is hereby amended with regard to the chapters and sections set forth below:

Chapter 6 - Water Service (Rev. Ord. 95-5, 2/20/95)

6.13(A) Water User Charge

WITHIN THE CORPORATE LIMITS: (Rev. Ord. 84-20, 10/1/84; Ord. 87-8, 4/20/87; Ord. 89-21, 9/18/89; Ord. 91-03, 5/20/91; Ord. 95-12, 7/10/95)

3/4" meter or smaller	\$ 2.50
1" meter	\$ 5.00
1 1/2" meter or smaller	\$ 10.00
2" meter	\$ 15.00
3" meter	\$ 25.00
4" meter or smaller	\$ 35.00
6" meter	\$ 55.00

Outside Corporate Limits (Rev. Ord. 95-9, 2/20/95; Ord. 95-12, 7/10/95)

All rates for service to properties outside the East Dundee corporate limits shall be 100 percent of the rates set forth above. Nothing herein contained shall be construed to require or obligate the Village to permit such connection. (Ord. 98-12, 7/13/98)

Section Three. Severability. If any section, paragraph or provision of this resolution shall be held to be invalid or unenforceable for any reason, the invalidity or unenforceability of such section, paragraph or provision shall not affect any of the remaining provisions of this ordinance.

Section Four. Repeal. All ordinances, resolutions, motions or parts thereof in conflict herewith shall be and the same are hereby repealed.

Section Five. Publication. This ordinance shall be in full force and effect forthwith upon its adoption, approval and publication in pamphlet form as provided by law.
