**RESOLUTION AUTHORIZING THE EXECUTION OF  
A FOUR EASEMENT AGREEMENTS FOR THE  
ILLINOIS ROUTE 25 WATER MAIN EXTENSION**

**WHEREAS**, the corporate authorities of the Village of East Dundee have determined that it is advisable, necessary and in the public interest that the Village enter into and authorize the execution of an Easement Agreement for public utilities with James T. Borello, Trust No. 1 for the property commonly known as 151 Dundee Avenue, East Dundee, PIN: 03-23-430-025; an Easement Agreement for public utilities with James T. Eev and Sabrina J. Even for the property commonly known as 155 Dundee Avenue, East Dundee, PIN: 03-23-430-026; an Easement Agreement for public utilities with Ronald C. Belter and Diane J. Belter for the property commonly known as 159 Dundee Avenue, East Dundee, PIN: 03-23-430-034; and an Easement Agreement for public utilities with Harris Bank Barrington, Trustee under Land Trust No. 11-5309 for property bearing PIN: 03-23-479-004; copies of which Easement Agreements are attached hereto as exhibits.

**NOW THEREFORE BE IT RESOLVED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF EAST DUNDEE, COOK AND KANE COUNTIES, ILLINOIS, AS FOLLOWS:**

**Section One.** That the Village of East Dundee adopts and approves and the President be and she is hereby authorized and directed to sign and the Village Clerk is directed to attest to the acceptance of an Easement Agreement for public utilities with James T. Borello, Trust No. 1 for the property commonly known as 151 Dundee Avenue, East Dundee, PIN: 03-23-430-025; an Easement Agreement for public utilities with James T. Eev and Sabrina J. Even for the property commonly known as 155 Dundee Avenue, East Dundee, PIN: 03-23-430-026; an Easement Agreement for public utilities with Ronald C. Belter and Diane J. Belter for the property commonly

known as 159 Dundee Avenue, East Dundee, PIN: 03-23-430-034; and an Easement Agreement for public utilities with Harris Bank Barrington, Trustee under Land Trust No. 11-5309 for property bearing PIN: 03-23-479-004; copies of which Easement Agreements are attached hereto as exhibits.

**Section Two. Severability.** If any section, paragraph or provision of this resolution shall be held to be invalid or unenforceable for any reason, the invalidity or unenforceability of such section, paragraph or provision shall not affect any of the remaining provisions of this resolution.

**Section Three. Repeal.** All ordinances, resolutions, motions or parts thereof in conflict herewith shall be and the same are hereby repealed.

**Section Four. Publication.** This resolution shall be in full force and effect forthwith upon its adoption, approval and publication in pamphlet form as provided by law.

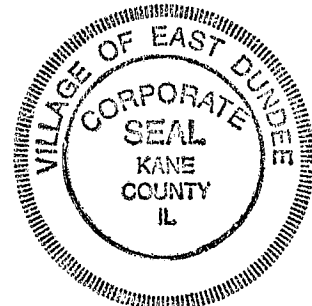
