

ORDINANCE NO. 05 - 08

**ORDINANCE AMENDING THE EAST DUNDEE
CODE OF ORDINANCES, TITLE I,
GENERAL PROVISIONS, CHAPTER 10,
RULES OF CONSTRUCTION**

WHEREAS, the Village of East Dundee is a home rule unit of local government under and pursuant to Section 6 of Article VII of the Constitution of the State of Illinois, has the authority to exercise any power and perform any function pertaining to its government and affairs, including but not limited to the power to regulate for the protection of the public health, safety, morals, and welfare; and

WHEREAS, the President and Board of Trustees of the Village of East Dundee having determined that it is in the best interests of the health, safety, and welfare of the residents of the Village of East Dundee that the East Dundee Code of Ordinances, Title I, **General Provisions**, Chapter 10, **Rules of Construction**, be amended.

NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF EAST DUNDEE, COOK AND KANE COUNTIES, ILLINOIS, AS FOLLOWS:

Section One. That the East Dundee Code of Ordinances, Title I, **General Provisions**, Chapter 10, **Rules of Construction**, be amended by deleting the current section numbering and substituting the following:

Section Two. That Section 10.06 be adopted as follows:

- 10.06 **FISCAL YEAR.** The fiscal year of the Village of East Dundee shall commence on the first day of May in each year.

Section Three. That Section 10.07 be adopted as follows:

- 10.07 **INAUGURATION FOR NEWLY ELECTED OFFICERS.** That the date for inauguration for the newly elected officers of the Village of East Dundee shall be the first regular or special meeting of the corporate authorities in the month of May following such election.

Section Four. Severability. If any section, paragraph or provision of this resolution shall be held to be invalid or unenforceable for any reason, the invalidity or unenforceability of such section, paragraph or provision shall not affect any of the remaining provisions of this ordinance.

Section Five. Repeal. All ordinances, resolutions, motions or parts thereof in conflict herewith shall be and the same are hereby repealed.

Section Six. Publication. This resolution shall be in full force and effect forthwith upon its adoption, approval and publication in pamphlet form as provided by law.
