

**ORDINANCE NUMBER 10 - 09**

**ORDINANCE AMENDING TITLE XI,  
BUSINESS REGULATIONS, CHAPTER 110,  
SECTION 110.04 AND SECTION 110.05(2) FROM THE VILLAGE OF  
EAST DUNDEE CODE OF ORDINANCES AND CHAPTER 110 OF  
THE ANNUAL FEE SCHEDULE**

**WHEREAS**, the Village of East Dundee is a home rule unit of local government under and pursuant to Section 6 of Article VII of the Constitution of the State of Illinois, has the authority to exercise any power and perform any function pertaining to its government and affairs, including but not limited to the power to regulate for the protection of the public health, safety, morals, and welfare; and

**WHEREAS**, the President and Board of Trustees of the Village of East Dundee having determined that it is in the best interests of the health, safety and welfare of the residents of the Village of East Dundee that the East Dundee Code of Ordinances, Title XI, Business Regulations, Chapter 110, General Licensing Provisions, Section 110.04 and Section 110.05 (2) in addition to, Chapter 110 of the Annual Fee Schedule be amended.

**NOW THEREFORE BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF EAST DUNDEE, COOK AND KANE COUNTIES, ILLINOIS, AS FOLLOWS:**

**Section One.** That the East Dundee Code of Ordinance, Title XI, Business Regulations, Chapter 110, General Licensing Provisions, Section 110.04, and Section 110.05 (2) be amended as follows.

§ 110.04           PROCEDURE AND DURATION.

All businesses operating in the village, including those operating from a residence, shall register with the village, no later than January 31 of each year, or at such time as the business desires to commence operation in the village. Registration forms shall be made available by the village. The required fee for each registration shall be collected in full at the time of the issuance and delivery thereof. In no event shall any rebate or refund be made of any fee, or part thereof, by reason of the death of the registrant or by any reason of non-use of the registration or discontinuance of the operation of the business.

ANNUAL REGISTRATION FEE

(2) *Annual renewal.* All fees and charges shall be paid at the time a business registration application is filed with the village. The annual registration fee shall be due and payable no later than January 30 of each year. Issued business registrations shall expire on December 31 of that calendar year. Renewal of business registration shall be for a full 12-month period and shall not be prorated for business conducted for a portion of the year. It shall be the responsibility of the registrant to provide a new and updated registration form at the annual renewal date. A renewed business registration will not be issued by the village until an updated registration form is completed and all the required information is provided.

**Section Two. Annual Fee Schedule.** The Annual Fee Schedule shall read as follows:

CHAPTER 110, GENERAL LICENSING REGULATIONS, TITLE XI, BUSINESS REGULATIONS:

Annual Registration Fee: Annual registration fees and renewals thereof for Business and Rental Registration shall be due annually on January 31 of each calendar year. There shall be no proration of such fees for new registrations of partial years. The Annual Registration Fee shall be \$25.00 if paid on or before January 31 and an additional \$5 fee will be assessed for payments made between January 31<sup>st</sup> and March 1<sup>st</sup>. Any business not registered by March 1<sup>st</sup> is subject to issuance of a citation in addition to the registration fee.

**Section Three. Severability.** If any section, paragraph or provision of this ordinance shall be held to be invalid or unenforceable for any reason, the invalidity or unenforceability of such section, paragraph or provision shall not affect any of the remaining provisions of this ordinance.

**Section Four. Repeal.** All ordinances, resolutions, motions or parts thereof in conflict herewith shall be and the same are hereby repealed.

**Section Five. Publication.** This ordinance shall be in full force and effect forthwith upon its adoption, approval and publication in pamphlet form as provided by law.
