

**RESOLUTION NUMBER 13 -13**

**RESOLUTION AUTHORIZING THE VILLAGE PRESIDENT, WITH  
THE CONCURRENCE OF THE VILLAGE BOARD TO APPOINT A  
VILLAGE CLERK  
PURSUANT TO 65 ILCS 5/3.1-25-90**

**WHEREAS**, the Village of East Dundee is a home rule unit of local government under and pursuant to Section 6 of Article VII of the Constitution of the State of Illinois, has the authority to exercise any power and perform any function pertaining to its government and affairs, including but not limited to the power to regulate for the protection of the public health, safety, morals, and welfare; and

**WHEREAS**, the Village Clerk is, pursuant to Section 31.16 of the Village of East Dundee Code, is an elected position; and

**WHEREAS**, the previous Village Clerk, Jennifer Rehberg, has resigned, and no candidate filed for that office for the April, 2013 Election; and.

**WHEREAS**, the Illinois Municipal Code, 65 ILCS 5/3.1-25-90, provides that in villages under 5000 in population, clerks can be appointed if authorized by a resolution adopted by not less than two-thirds of the village board; and

**WHEREAS**, the Illinois Municipal Code, 65 ILCS 5/3.1-25-90, provides that the Village President, with the concurrence of the Village Board may make such appointment.

**NOW THEREFORE BE IT RESOLVED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF EAST DUNDEE, COOK AND KANE COUNTIES, ILLINOIS, AS FOLLOWS:**

**Section One.** All of the above Whereas clauses are hereby incorporated by reference.

**Section Two.** The Village President is authorized, pursuant to 65 ILCS 3/3.1-25-90, to appoint a Village Clerk with the concurrence of the Village Board.

**Section Three. Severability.** If any section, paragraph or provision of this ordinance shall be held to be invalid or unenforceable for any reason, the validity or unenforceability of such section, paragraph or provision shall not affect any of the remaining provisions of this ordinance.

**Section Four. Repeal.** All ordinances, resolutions, motions or parts thereof in conflict herewith shall be and the same are hereby repealed.

**Section Five. Publication.** This ordinance shall be in full force and effect forthwith upon its adoption, approval and publication in pamphlet form if required by law.
