**A RESOLUTION AUTHORIZING THE EXECUTION OF THE
AGREEMENT BETWEEN CHAPMAN AND CUTLER, L.L.P. AND

TAX INCREMENT FINANCING (ROUTE 25)**

WHEREAS, the Village of East Dundee is a home rule unit of local government under and pursuant to Section 6 of Article VII of the Constitution of the State of Illinois, has the authority to exercise any power and perform any function pertaining to its government and affairs, including but not limited to the power to regulate for the protection of the public health, safety, morals, and welfare; and

WHEREAS, it is deemed necessary and desirable for the Village of East Dundee to enter into the Agreement with Chapman and Cutler, L.L.P. for bond services in connection with proposed Tax Increment Financing (Route 25).

NOW THEREFORE BE IT RESOLVED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF EAST DUNDEE, COOK AND KANE COUNTIES, ILLINOIS, AS FOLLOWS:

That the Village of East Dundee adopts and approves and the President be and he is hereby authorized and directed to sign and the Village Clerk is directed to attest to the execution of the Agreement with Chapman and Cutler, L.L.P. for bond services in connection with proposed Tax Increment Financing (Route 25), a copy of which Agreement is attached hereto and made a part hereof.
