

ORDINANCE NUMBER 11-54

**ORDINANCE ESTABLISHING VILLAGE OF EAST DUNDEE
HOUSING ASSISTENCE PROGRAM**

WHEREAS, the Village of East Dundee is a home rule unit of local government under and pursuant to Section 6 of Article VII of the Constitution of the State of Illinois, has the authority to exercise any power and perform any function pertaining to its government and affairs, including but not limited to the power to regulate for the protection of the public health, safety, morals, and welfare; and

WHEREAS, the President and Board of Trustees have identified, in the Comprehensive Plan and otherwise, a need for quality, affordable rental housing units within the Village of East Dundee; and

WHEREAS, the President and Board of Trustee have determined that it is in the best interests of the public health, safety, morals, and welfare to approve and implement the attached Village of East Dundee Affordable Housing Program.

NOW THEREFORE BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF EAST DUNDEE, COOK AND KANE COUNTIES, ILLINOIS, AS FOLLOWS:

Section One. That the President and Board of Trustees do hereby incorporate the foregoing WHEREAS clauses into this ordinance as though fully set forth herein, thereby making the findings as hereinabove set forth.

Section Two. That the President and Board of Trustees do hereby approve and adopt the Village of East Dundee Affordable Housing Program, a copy of which is attached to this ordinance.

Section Three. That the Village Administrator is hereby authorized and directed to take such actions as may be required to implement the Village of East Dundee Affordable Housing Program Policy.

Section Four. Severability. If any section, paragraph or provision of this ordinance shall be held to be invalid or unenforceable for any reason, the validity or unenforceability of such section, paragraph or provision shall not affect any of the remaining provisions of this ordinance.

Section Five. Repeal. All ordinances, resolutions, motions or parts thereof in conflict herewith shall be and the same are hereby repealed.

Section Six. Publication. This ordinance shall be in full force and effect forthwith upon its adoption, approval and publication in pamphlet form as provided by law.

Section Seven. Effective Date. Passed on the 19th day of December, 2011, according to the following roll call vote.
